On 11-5-86 at approx. 7:00 P.M. I went to 808 Sierra Slope and spoke with Terry Wills, her mother, and her two brothers. When Terry was questioned about the incident on 8-26-86, she stated that she had been to the doctor with her grandfather. When he brought her home, she changed clothes as she watched Different Strokes on T.V. She stated that after her program was over, she went outside to ride her bicycle. She then saw Mr Graf driving a white colored car with Joby in the car with him. Joby was reading a comic book, possibly a Superman one because he always liked to read these. She did not see Jason in the vehicle. Terry stated that she thought Joby and Jason had company because the car that she saw was not the one that was usually at the Graf residence. When she was asked about what she had told Detective Latham prior, she stated that she did not remember stating that she saw the white car in the driveway at the Graf residence prior to seeing it being driven by Mr Graf, down Sierra Slope turning onto Angel Fire. Terrys' mother questioned Terry about the incident because Mrs Willis stated that she distinctly remembered her husband telling her that Terry had told detective Latham tyat she saw the white car in the driveway at the Graf residence and later saw it being driven by Mr Graf with Joby inside. Terry could not remember the incident other than only seeing the car being driven by Mr Graf after 4:00 PM because of the time that the TV program was finished.

Terry also related an incident where she had a little kitten that she needed a box to keep it in. She asked Joby if he had a box and he took her to his outside shed. Joby then went inside his house and returned with a key and unlocked the shed, removed a box and gave it to Terry and told Terry not to mention this to his father as he was not allowed to go into the shed.
