7 THE COURT: Madam Foreman, has the  
8 jury reached a verdict?

9 THE FOREMAN: We have, Your Honor.

10 THE COURT: Would you hand the verdict  
11 to the Bailiff.

12 Would the Defendant please rise.

14 (The Defendant complies.)

15  
16 The answer to Question Number 1 is  
17 "Yes." The answer to Question Number 2 is "Yes."  
18 You may be seated. It is signed Foreman Phylis  
19 Griggs Thurston, Foreman of the Jury."

20 Do you wish to poll the jury?

21 MR. MCCOLLOUGH: Yes, Your Honor.

22 THE COURT: All right. Priscilla  
23 Coffey, is this your verdict?

24 THE JUROR: Yes, it is.

25 THE COURT: Carmel Booth, is this your

1 verdict?

2 THE JUROR: Yes, it is.

3 THE COURT: Mary Ann Desrosiers, is  
4 this your verdict?

5 THE JUROR: Yes, it is.

6 THE COURT: Mary Bradford, is this  
7 your verdict?

8 THE JUROR: Yes, it is.

9 THE COURT: Katherine Anderson, is  
10 this your verdict?

11 THE JUROR: Yes, it is.

12 THE COURT: Jane Pacetti, is this your  
13 verdict?

14 THE JUROR: Yes, it is.

15 THE COURT: Jean Morris, is this your  
16 verdict?

17 THE JUROR: Yes, it is.

18 THE COURT: Jerry Ayers, is this your  
19 verdict?

20 THE JUROR: Yes, it is.

21 THE COURT: Eliberto Lopez is this  
22 your verdict?

23 THE JUROR: Yes, sir.

24 THE COURT: Lawrence Pencak, is this  
25 your verdict?

1 THE JUROR: Yes, it is.

2 THE COURT: Phylis Thurston, is this  
3 your verdict?

4 THE JUROR: Yes, it is.

5 THE COURT: David Lindenmann, is this  
6 your verdict?

7 THE JUROR: Yes, it is.

8 THE COURT: Brenda Parmer, is this  
9 your verdict?

10 Oh, I'm sorry. That's the first  
11 alternate. Excuse me.

12 The Court has polled the jury, and the  
13 reply is unanimous.

14 All right. Ladies and gentleman of  
15 the jury, that concludes your jury service here,  
16 and it's been a long one and it's been a very  
17 difficult one. And everyone in this courtroom  
18 knows it has been a difficult jury service. We  
19 came in from out of town and imposed upon the  
20 hospitality of Tom Green County. We imposed  
21 upon your hospitality, and everyone in this  
22 county has been gracious to us and kind to us,  
23 and you have been diligent, hard working  
24 citizens for the County of Tom Green and for the  
25 County of Williamson in this case, and we from

1 Williamson County appreciate it. And so we  
2 thank you for the hard work you have done and  
3 the difficult, difficult decision that you had  
4 to make. And so I want to start by saying  
5 thanks.

6 I secondly want to tell you that I  
7 have a little gift that I give to each of my  
8 jurors, which is a certificate saying that they  
9 have served in jury service. However, it's  
10 going to have a picture of the Williamson County  
11 Courthouse on the front of it, not the Tom Green  
12 County Courthouse. But I will -- I have gotten  
13 your names and addresses from the Clerk, and I  
14 will be mailing you a certificate from  
15 Williamson County, certifying that you have  
16 served on this jury in this jury service, and  
17 you should be receiving that hopefully in a week  
18 or so after I get back home.

19 The lawyers in this case, they make  
20 their living working with jurors and in court  
21 the way a carpenter works with hammers and nails.  
22 And they may want to talk to you about this, and  
23 they have talked to me. Now, I have understood  
24 that you really don't want to talk to the press  
25 tonight, and that's fine. I've asked the press
