Summary of Investigation, Officer's Opinion, Background to Case:

I received a call to go to Roebne Park in reference to missing persons. When I arrived I met with Mr. RICHARD FRANKS who is the father of KENNETH FRANKS. Mr. FRANKS informed me that the two above females had come to Waco on 7-13-82 and had called his son at home. Mr. FRANKS stated that they were at El Chico's when they called KENNETH at the residence and informed KENNETH that they were going to come by the house and pick him up. Mr. FRANKS stated that the two girls came by the house at approximately 9:00P, 7-14-82 in an orange 1977 Ford Pinto. He stated that KENNETH then got into the car with the two girls and they drove off. Mr. FRANKS stated that he did not hear from any of the three subjects again and it was very unlikely for his son not to call or to come back home because he and his son have a close relationship. Mr. FRANKS stated that KENNETH also could not afford to miss another day at summer school as he had already missed too many days, and it he could not miss anymore days at summer school.

Mr. FRANKS stated that he contacted RAYLENE RICE'S father in Waxahachie, Texas and that her father had stated that RAYLENE did not show up for work in Waxahachie. Mr. RICE also stated that RAYLENE did not inform him that she was leaving Waxahachie and going to Waco.

Mr. FRANKS had also found out that JILL MONTGOMERY was living with her mother by the name of NANCY SHAW at an unknown address in Waxahachie, phone number 937-0336. JILL MONTGOMERY also did not inform her mother that she was going to Waco from Waxahachie.

Mr. FRANKS had contacted Mr. RICE at phone number 937-9354 in Waxahachie, Texas. Mr. FRANKS then began driving around trying to find where these three subjects may possibly be and he went to Koehne Park as his son goes down there quite often. He stated that when he drove into Koehne Park he took the first left that goes around to the picnic area into Koehne Park and found the orange Pinto parked at the scene. He stated that he did not find the whereabouts of the three subjects that were in the Pinto however. It was at this time that he called me to the scene.

I checked around in Koehne Park and I did not locate any signs of foul play, however, it seemed unusual to me that the passenger side door of the Pinto was opened and that there was jewelry laying in the car console on the inside of the car. KENNETH FRANKS had also apparently left his keys in the back seat of the car. I had noticed three pairs of shoes laying by a picnic table close to where the car was parked. Mr. FRANKS examined these shoes, however, he stated that he did not think that these shoes belonged to his son or the two girls as he knows what type of shoes his son wears and none of the shoes fit that description.

Mr. FRANKS had informed me also that JILL MONTGOMERY had been living at the Methodist Home in Waco and that she has just recently moved back with her mother in Waxahachie. Mr. FRANKS stated that by talking to the other sets of parents, that none of these kids have done anything like this before and they are very concerned about their safety. Mr. FRANKS

contacted KENNETH's best friend who met me in Koehne Park. He identified himself as PATRICK TORRES of 1724 N. 11th, phone number 756-4872. PATRICK TORRES informed me that KENNETH had called him at approximately 6:00P, 7-13-82, however, he did not say anything about going out or going out with the two girls. PATRICK stated that he felt that this was unusual because he is KENNETH's best friend and that KENNETH usually tells him everything. I asked PATRICK if they went to Koehne Park often and he stated that they did. I asked him if they ever got into another person's vehicle and left their vehicle in Koehne Park. PATRICK said that they have never done this and that he did not think that KENNETH would do something like this because he knows of all of the crime incidents that have happened with vehicles in Koehne Park.

Mr. FRANKS had informed me that he had talked to Mr. RICE and that Mr. RICE wanted to come to Waco in order to pick the car up at around 12:00P, 7-14-82 so that it would not be sitting there during the night shift hours when it could possibly be tampered with or stolen.

I received a picture of KENNETH FRANKS from his father and I will give this to Sgt. FORTUNE for identification purposes.

I informed Mr. FRANKS that if he would call the parents of the two girls once again before they come to Waco, that they could also bring with them pictures of the two girls so that we could have them for identification purposes also.

The Pinto that is parked in Koehne Park is described as a 1977 orange Ford Pinto 2 DR with 1982 Texas plates NZV149.

After leaving Koehne Park, I called the dispatcher and gave her the information on the three missing subjects for general information for the rest of the patrol section in case they came in contact with any one of these three subjects. I also advised Mr. FRANKS that if he heard from one of these three subjects, to contact the PD upon finding out his information. Mr. FRANKS stated that after he got a hold of the two parents of the girls that he would have them contact either myself or Sgt. FORTUNE with any information
