In reference to this investigation, SGT. FORTUNE asked me to do a background investigation of JILL MONTGOMERY. At 10:45A, 7-15-82, I talked to MARY BELLHEIMER, her counselor while she was at the METHODIST HOME. I did receive a little bit of information at that time. However, at 1:15P, 7-16-82, I recontacted MARY BELLHEIMER and received more information. The mother of JILL MONTGOMERY is a NANCY MONTGOMERY SHAW, dob 2-25-41. Her father is RICHARD (ROD) JAY MONTGOMERY, dob 10-23-38. The parents were divorced in September of 78 due to general discord. No further information in reference to the marriage at this time. The father, RICHARD MONTGOMERY, remarried a woman named VANESSA, maiden name unknown, address unknown at this time. They have since divorced with the divorce being final within the last month. He is currently living with his parents in Waxahachie. After NANCY and RICHARD were divorced, NANCY married BENNY SHAW on September 20, 1980. They were divorced February 20, 1981 and then remarried within the last six months, date unknown. According to the counselor, there was no indication of any sexual abuse in the home by either father or stepfather. JILL was placed in the METHODIST HOME August 5, 1981 due to truancy and discipline problems at home. JILL appeared to be resentful of authority and missed school continuously while with her parents. She was continuously running away and going to parties and not doing the things her parents wished her to do. While at the METHODIST HOME, JILL generally got along well with the people there. There were discipline problems with the other kids. Most kids liked her and she got along well with them. She has been described as charming, personable, happy go lucky, having an easy, out-going personality. Some of the kids described her as being a little bossy and a "know-it-all". Reports indicate that she did use marihuana occasionally at or near school. After being placed in the METHODIST HOME unit, JILL went to WACO HIGH SCHOOL. In October of 81, MIKE GILCREST, address unknown, wanted to meet the home parents in order to date JILL. This meeting never took place. Therefore, it is unknown if he dated her at any time. JILL then started dating KENNETH FRANK up until about March or April. In school one day, he hit her, knocked her against the wall, the reason unknown. She said he was high. After the breakup, KENNETH started dating another girl named GAYLE KELLY, who is currently in the Perkin Unit and the METHODIST HOME.

After KENNETH and JILL broke up, JILL started dating a boy named BRYAN DALLAS, address possibly being 2104 Alexander, phone number 755-7848. It is unknown at this time if this is the correct address because the METHODIST HOME gave me an address of 204 Alexander which would be an incorrect address. The number of dates they had is unknown at this time. They dated until

May of 82 at which time, no more dates area known of. In January 1982, JILL ran away from the METHODIST HOME with a girl named RHONDA EVANS. RHONDA has since been released to the foster home of SALLY TUCKER, Rt. 1, Billington, phone 1-993-4341. JILL was picked up by her father at a house somewhere near 15th & Herring, description being as you go out the front of the parking lot, you could almost drive to the house except you have to circle around and according to the counselor, this means going up to 15th & Lyle and turning down 15th. She thinks maybe the house is on 15th, however there is a possibly it's around 13th or 14th & Proctor. The house is described as dirty white or gray two-story corner house with a vacant lot or gravel lot next to it. After picking her up, the father took her to the EL CONQUISTADOR Restaurant where she called her counselor about returning to the METHODIST HOME. She did return to the METHODIST HOME and a meeting was set up between JILL and her parent and counselor. JILL wanted to return home, however the father felt that she shouldn't at this time. Kids reported that while JILL was away, she stayed at the house of BOBBY BRIMS at 1905 Tanglewood. According to the counselor, some of the kids at the METHODIST HOME called BOBBY a "reco nurd" and a "weird-do". Also during school, JILL and KEN would go over to his house during lunch. Counselor stated that JILL loved to ski and would get into anybody's boat just to go skiing with them. She stated that JILL liked to chase boys and that was the thrill that she got was chasing the boys, however once she caught the boy and dated him a few times, she would stop dating them. JILL was released from the METHODIST HOME on July 10th, 1982. This is all the information I have from MARY BELLHEIMER, however she does have a file on JILL and was her counselor. This counselor, MARY BELLHEIMER is available if needed.
