at 2:00p 7/25/82, myself and sheriff deputy Abner, found Ronald Wayne Robinson parked across the street from the HEB at a friend's house. We asked Ronald Wayne Robinson if he would talk to us and he stated that he would accompany us to Koehne Park to show us what he had seen. Myself and Abner then drove him to Koehne Park where Ronald Wayne Robinson informed us that he had been driving in a friend's of his car by the name of John Kent of 525 N. 9th and that they were driving in a blue Plym, Duster, with a strip down the side of it with Louisiana license plates 45G-748. Robinson stated that at approx. 11:45p 7/13/82, he and Kent had left the Okey Dokey Club at Valley Mills and Wooded Acres and were driving a girl home. He stated that the girl was intoxicated, that he could not find out the address of where she lived, so they drove her to Koehne Park so they could try and revive her. While trying to revive her in Koehne Park they noticed a orange Pinto parked at the circle and they did not notice anyone around the Pinto. They stated that they saw another blue Plym Duster come into the parking lot and spin off and he stated that he had seen a white male subject driving the car at approx. 12:45a. He then stated that right after the blue Plym duster left a black Linc. Cont. pulled up next to John's car and the white male subject driving the car stated that he was looking for a blonde driving a white Carlo and had asked John if he had seen this car. John stated that he had not. The white male subject in the Linc. Cont. then said that his name was Bob and that he was smoking weed and hash, Bob then gave John phone number. Robinson described John as being a W/M with curly hair and as far as mustache with sideburns, he stated that he was wearing a pee cap (english style), Bob informed John that he would like to see them come to his apartment and meet some girls and that Bob had acted like he was in a hurry. John and Ronald both refused going to Bob's apartment and Bob just informed them that if they ever felt like having a good time to give him a call. Robinson described the Linc. as having a sliding T top or sunroof on top of the car. With the description of the subject in the black Linc. Cont, that Robinson described to me, it sounded as if it matched the same description as Robert Freeh.

Robinson informed me a little afterwards that he had thought these subjects in the blk Linc. Cont. were familiar to him and that he had had an old substitute teacher from Tennyson Jr. high school by the name of Mr. Freeh and that he had heard that Mr. Freeh was gay. I did not tell Robinson that I believed that the person in the Linc. Cont was Mr. Freeh at this time.
