On 8-4-82 at 11:08A, I started an interview with subject WILLIAM KEITH PAYNE who gave an address on Flat Rock Road somewhere, as he did not know his parents address. He is a WM on 8-10-61. He is 5-7 and 140 lbs. with brown hair and blue eyes. He went to Richfield School and quit in the 11th grade. He related to me the following information.

On Saturday, July 31st that he had met his dad along with his brother DAVID PAYNE at the Elite at the Circle. They sat and had coffee and talked. He further related to me that they went to the Sonic Valley Mills Dr. where they obtained hamburgers and french fries and the father drove them down to Koehne Park where he let them out. They ate their hamburgers and went swimming and they had their suitcase with them because they had just arrived in town from Bryan, Tx where they had lived prior to getting into Waco Friday night, July the 30th. The suitcase they had with them being a blue naugahyde that they hid in the bushes so that they could go swimming and would not have to worry about watching the suitcase.

When they finished swimming a blue pickup truck being a Datsun pulled up beside them and asked them if they wanted to go for a ride. He told me that this was somewhere around 1:30 to 2:00 in the afternoon and they said, sure. The subject then pulled up to the top of the hill there by the Hilltop Grocery, went in and bought a 6-pack of beer and then had the younger brother DAVID to get into the front seat with him. He then drove to Jones-Blair Paint Center on Valley Mills Dr., were supposedly the uncle of the driver of the blue Datsun pickup whom they found to be JAMES LUCAS, better known as BLINKY. The uncle being RALPH whose last name is FINSTAD works there at Jones-Blair Paint. Once they arrived at Jones-Blair Paint, they smoked a joint and RALPH supposedly brought out a white substance and asked them if they wanted some angel dust. Then BLINKY supposedly told the little brother to go lie down, that he looked tired, and that he would join him in a little while, but he refused to do so and shortly they left Jones-Blair Paint and drove to a house on Rambler Dr. somewhere which he did not know the address or could not give me any names of people who lived on Rambler Dr. However, BLINKY did supply this information to us a later date.

After leaving the house on Rambler Dr., they drove to Cameron Park and laid around on a picnic table and then at about 8:20 to 8:30, they drove to th Brazos Queen and stayed there for a while while, and then went to Sambo's and had no money, but yet they drank some coffee and BINKY borrowed some money from a waitress to pay for the coffee they drank. Around 11:00P they went to the LaQuinta.

RALPH FINSTAD works part-time as a clerk at LaQuinta and he advised BLINKY that if they wanted to sleep down there, that he could give them a room and write it off as a dirty room and it would not cost anything, so when they arrived at the LaQuinta, they did obtain a room and the three went to the room to sleep. Prior to going to the room, RALPH gave BLINKY \$10 and said, "go buy the boys some beer". They went and bought a 12-pack of Miller Lite and returned to the room at the LaQuinta. He could not remember the room number. He stated that it was on the southside far end at the back section of the motel LaQuinta. He said that around 3:30 or 4:00 in the morning, they had all been asleep and he was awakened by BLINKY standing in the middle of the room completely nude and subject had a knife in one hand and had his hand on his privates and was yelling, "Please, let me suck your Dick" They became frightened and both DAVID & KEITH jumped up and ran outside with just their underwear. They stated that BLINKY started saying, "hey, I didn't mean it, come on back in". They went in and got their clothes and sat out in front of the motel until morning. They then were taken by BLINKY to Valley Mills Dr. where he let them off by Sun Harvest Grocery. The subject BLINKY then left. KEITH stated that they then called his dadcy and related the story to him, that BLINKY had told them during this period of time while they had been at the Jones-Blair Paint that BLINKY had related this information to them.

KEITH stated that BLINKY had told them that he had been involved in the murders. He asked them if they knew anything about the murders. He then began telling them that he could take them where the bodies had been found. He also stated that he had done some things to the WFs and that all women were good for was to take a man's dollars. He further stated that he had killed and stabbed the folks involved. He stated that he had taken the knife and had shoved it up the girls' vagina area. He went on further to say that they had better not tell anyone because they could not prove what he had said anyway. BLINKY did talk to

COLINAS in reference to this and also Sgt. FORTUNE. Their report will reflect his information concerning this. The subjects then on the date of 8-3-82^{at} to 1201 Wooded Acres which is Sambo's. Two subjects KEITH & DAVID decided to meet RALPH. They were supposed to talk with RALPH to see if they could get anymore information on the murders of the three in Speegleville Park. They stated that they went first to Jones-Blair Paint and then to Sambo's; that RALPH had told them that BLINKY wanted to talk with them and that he would meet them at Sambo's around 10:30 or 11:00. They did go to Sambo's, however, prior to BLINKY's arrival, the father supposedly was with them or following them when all of this occurred and while they were in Sambo's supposedly the subject RALPH stabbed DAVID in the abdomen area. KEITH told me that he did not see the stabbing take place, but only his brother had told him that RALPH had stabbed him. Apparently they were all right there at the table and no one actually saw RALPH do the stabbing that we have been able to prove.
