

1 If the Sheriff can say, I do recall, okay.
2 If not, that's all the -- you will have to
3 back the tape up and you will have to ask
4 that at that time of the Sheriff. When Mr.
5 Walsh is through with the Sheriff, you can
6 put your witnesses on.

7 MR. PARKER: I understand.

8 MR. WALSH: I'm through with the Sheriff,
9 Your Honor.

10 THE COURT: All right, step down.

11 MR. PARKER: We will renew our other
12 objections to the exhibit.

13 THE COURT: Objection is overruled.
14 Call your witness.

15 MR. PARKER: We call Sue Bramhall, the
16 District Clerk of Tom Green County.

18 SUE BRAMHALL

19 was called as rebuttal witness by the Defense and,
20 being first duly sworn, was examined and testified
21 on her oath as follows:

22
23 DIRECT EXAMINATION

24 BY MR. PARKER:

25 Q Would you state your name for the record?

1 A Sue Bramhall.

2 Q What is your address?

3 A My address, 3226 Woodlands, San Angelo, Texas.

4 Q What is your occupation?

5 A District Clerk of Tom Green County.

6 Q Have you been present in the courtroom while
7 State's Exhibit 102, which was an edited videotape,
8 was played in the courtroom?

9 A Yes.

10 Q Were you present during the time that this
11 discussion was had as to a particular language
12 in the tape?

13 A Yes.

14 Q I don't have any transcript of the actual tape,
15 so I don't want to ask you a leading question,
16 but was there one part of the tape that you heard
17 on State's Exhibit 102 -- did you or did you not
18 hear any portion that referred to or sounded like
19 it referred to something about murder?

20 A Well, a lot of it referred to something about
21 murder that I listened to.

22 Q I'm talking about the edited video.

23 A Yes, uh-huh.

24 Q In your own words, how did it sound to you? What
25 did you hear?

1 A The part that's in question, it sounded like
2 "We go from one place to murder, from one murder
3 to another. We were on the -- we roam the country,"
4 or something like that.

5 Q And where were you sitting at the time you heard
6 these tapes?

7 A I was sitting in the jury box.

8 Q All right. And was the tape played back on three
9 or four occasions?

10 A Yes.

11 Q Is that what you heard?

12 A Yes.

13 Q For the purposes of the record, have we had
14 problems in this courtroom with the acoustics?

15 A I don't know.

16 Q All right. You may not have been present
17 throughout the trial.

18 A I can't say yes or no for that.

20 MR. PARKER: That's all I have, Your
21 Honor.

THE COURT: Mr. Walsh?
