SGT. SIMONS & I talked with LISA KADER on 9-11-82 at approx. 10:A at the METHODIST HOME. We did ask her if she knew KENNETH FRANKS and she said that knew him from the METHODIST HOME and liked him. We did question her in reference to any knowledge of the murders of KENNETH FRANKS, JILL MONTGOMERY or RAYLENE RICE due to the fact she did contact this agency in reference to information immediately after the bodies were found. She responded by saying that she believed that MUNEER MOHAMMAD DEEB did kill the people. LISA KADER said that DEEB became irate at the mere mention of KENNETH FRANKS' name. She said that she was in the store one day before the murder and that DEEB had made the remark that he (DEEB) was going to put KENNETH FRANKS in the hospital. LISA KADER did go to the store at 1423 Herring, known as the RAINBO DRIVE IN and did know MUNEER MOHAMMAD DEEB, aka: LUCKY. LISA KADER said that DEEB gave her and friends of hers free soft drinks and other things. According to LISA KADER DEEB also gave her and her friends handrolled cigarettes containing marihuana.

We did ask her, in reference to any associates or friends of DEEB'S that she knew, and she stated that she knew a white male that was a friend of DEEB'S however she could only give us his first name which was DAVID, aka: CHILI. She said that DAVID portrayed himself to be a biker. LISA KADER said that she and a FAYE PEARSON had doubledated with DAVID and another friend by the name of ROBERT COLEMAN.

LISA KADER did say that she had been in the RAINBO STORE with FAYE PEARSON when DEEB had pulled a pistol from underneath the counter and showed them. She said that he was waving it around and did frighten her with it.

LISA KADER could give no other information in reference to the friends of DEEB or any other information in reference to the relationship between KEN FRANKS and DEEB.

At approx. 1:A, 9-11-82, Saturday morning, SGT. SIMONS & I went to SKAGGS SUPERMARKET, located at 1900 N. Valley Mills Dr. and talked with Security OFFICER WILLIE TOMPKINS and a checker by name of PATTY PICK.

PATTY PICK was a friend of MUNNEER DEEB as was WILLIE TOMPKINS. WILLIE TOMPKINS knew DEEB from DEEB coming into SKAGGS late at night talking with him. TOMPKINS also had some electronic games in DEEB'S store located at 1423 Herring.

PATTY PICK became friends with DEEB also because of DEEB coming into SKAGGS STORE late at night. PATTY PICK said that DEEB would talk to her and confide in her. She said that the main reason that DEEB talked with PATTY that she was a friend of KEBANA REED who PATTY PICK was friends with. DEEB had told PATTY PICK several times that he loved KEBANA. PATTY PICK said that everytime that DEEB would come into the store he would ask PATTY PICK about KEBANA REED and if KEBANA had asked about DEEB.

PATTY PICK said that DEEB did tell her and WILLIE TOMPKINS one morning that he was glad that KEN FRANKS was dead and that he did not like KENNETH FRANKS.

DEEB had at one time asked PATTY PICK to get the key to the apartment that KEBANA REED lived from KEBANA REED'S sister, CHRISNA REED who also works at SKAGGS. He asked PATTY PICK to get the key from CHRISNA REED'S purse, give it to him, he would take it and get one made and then return the key to PATTY PICK so that she could return the keys to CHRISNA REED'S purse without CHRISNA REED knowing of them being gone.

WILLIE TOMPKINS did confirm that he was with PATTY PICK when DEEB told them that he was glad that KENNETH FRANKS was dead. WILLIE TOMPKINS did see DEEB quite often and did see him buy large amounts of groceries for KEBANA REED & CHRISNA REED. WILLIE TOMPKINS noticed DEEB'S violent verbal outburst when WILLIE T. along with others at the SKAGGS STORE had moved DEEB'S car so that DEEB could not find it. DEEB became violent and angry until he found out that WILLIE TOMPKINS moved the car. WILLIE TOMPKINS said that it took DEEB approximately 5 min. before he could calm down where they could talk about it.
