DETAILS

At approximately 7:00PM, I was asked by Hewitt Deputy Fire Chief Tom Lucenay to come by the Fire Department where all Hewitt Firemen were having their weekly meeting and talk to them about the statements we required. I briefly told them the State Fire Marshal was going to review the fire case and we needed a written statement from each one who was at this fire, outlining their notification, arrival, actions taken, observations, etc., including times, locations, etc. I done this evening and turned into Lucenay the next day, signed and with a phone number in case we needed any more information. Lucenay and Curtis McLemore said they would obtain them and get them to us as soon as possible. No questions were asked and no other information was given out.
