DETAILS

On 09-05-86, this Officer spoke with DENISE MARTIN, D.O.B. 12-02-45. Ms. Martin lives at 748 Castleman Creek. Ms. Martin stated she heard the fire call over the scanner. About the same time, her neice, TRACY NEIE, came into the house and said that there was a fire up the street. Both Ms. Martin and Miss Neie went outside to look and saw a lot of dark, black smoke but no flames. Both persons then started walking toward the burning building. Ms. Martin stated she heard an explosion. This explosion was not loud or sharp but muffled.

Ms. Martin stated they (denise and Tracy) arrived at the scene prior to the Fire Department arriving. Ms. Martin observed three(3) men standing on the porch. All three(3) men appeared disoriented. These men went to the left side or North end of the house, that gate was locked. The three(3) men then went to the right or South end of the house in an attempt to get into the back yard. After the fence to the North of the house was torn down, Ms. Martin stated the flames were high above the privacy fence. The fire was very fast and hot burning. Ms. Martin said she cold feel the heat across the street. Ms. Martin also stated she observed a man in the yard to the North of 505 Angel Fire spraying water on the fire. Ms. Martin also siad she had seen a man jump over the fence with a water hose. Ms. Martin was not sure if this person had jumped from 505 Angel Fire to the neighbors yard or the other way around. About that time, the Fire Department arrived on the scene. Ms. Martin said that the corner posts and part of the roof were still standing.

On 09-05-86, this Officer also talked with a Tracy Neie, D.O.B. 04-28-64, who lives at 748 Castleman Creek. Miss Neie stated she arrived home just a little before 5:00PM when she noticed smoke coming from up the street. Tracy and her Aunt, Denise Martin, went to the area of the fire. On the way up to this fire, Tracy stated she heard an explosion. The explosion sounded like a loud fire cracker. Explosion was heard two(2) blocks away. When Tracy arrived
