# Feazell complains of rights violation

District Attorney Vic Feazell said Friday he will file a complaint charging that Waco Police Chief Larry Scott, assistant U.S. Attorney Jan Patterson, Department of Public Safety Director Jim Adams and DPS investigator Ron Boyter "conspired to violate" his civil rights during meetings with burglary suspect Clyde Kelly Jr.

"I feel there has been a conspiracy to violate my civil rights, and I want it investigated," Feazell said.

Also on Friday, Waco attorney Charles McDonald said he believes Kelly was involved in at least one of three burglaries of his law office earlier this year, and that federal authorities questioning Kelly are aware of the burglaries.

Feazell said he will file the complaint with the U.S. Department of Justice next week.

Feazell claims that for the past three months Adams, Ms. Patterson, Scott and Boyter have been meeting at the Texas Rangers Headquarters at Fort Fisher or at Scott's office and have "offered Kelly federal protection and money to falsely testify against me."

He said his telephone has been tapped, his dog poisoned and his

bank records subpoenaed without his knowledge.

Ms. Patterson took custody of Kelly on Nov. 15. Feazell said he believes Ms. Patterson is attempting to establish a relationship between Feazell and Kelly and that Feazell ordered the offices of three Waco attorneys burglarized.

Ms. Patterson and Scott have declined comment on the Kelly investigation. Attempts to contact Ms. Patterson, Scott and Adams on Friday were unsuccessful.

"Which is it? Burglary, bribery or baloney?" Feazell asked Friday. "It's political. It's nothing but stark politics."

Feazell contends he has been investigated by the DPS, FBI, Waco Police Department and Internal Revenue Service for challenging confessions made by Henry Lee Lucas. The serial killer recanted most of his murder confessions during a McLennan County grand jury inquiry headed by Feazell.

Feazell said that to his knowledge he never met Kelly and never ordered any burglaries. He said he has read a statement Kelly made about a burglary of McDonald's law office.

"I can't discuss what the confession says, but it doesn't say any-

thing about me," Fezell claimed.

McDonald said the offices of McDonald, Harmon & Malone, 3302 West Waco Drive, were burglarized three times in May and June.

"It's my understanding that there's no question Kelly was in this office on one or more occasions — physically, without consent, entered this office," McDonald said.

McDonald said federal authorities are aware of the burglaries, but he does not know if Fezell was supposed to be behind the burglaries.

"I really can't speculate on what that man might do, or might not do," McDonald said.

Kelly's new attorney, Rod Goble, said Friday he has not seen the confessions.

McDonald, who has practiced law in Waco for 27 years, said in all three burglaries files were shuffled, cabinets and desks searched and briefcases broken into.

"They weren't what you'd consider an ordinary burglary. There were lots of things of value to take, but they didn't."

McDonald said some jewelry was taken from his desk, but the burglars left recorders, copiers and other valuable items.

He said no files were stolen and

he does not know what files the burglar was looking for.

Crawford Long, an assistant prosecutor in Fezell's office, said Kelly has been indicted for burglary of Genecov Food Distributors at 305 South Thirteenth, the residence of Waco police officer Don Cannon and the home of Crawford school superintendent Kenneth Judy.

Long said Kelly has not been indicted for burglary of McDonald's law office and that he is not concerned about Ms. Patterson's taking custody of Kelly.

"The state's position is to prepare the cases. I'll be glad to go to trial as soon as they're set in 54th District Court," Long said.

Waco police say Kelly, 21, led a ring responsible for more than 125 burglaries in 1984 and 1985.

Goble said Kelly is being questioned about "gun charges" but said he could not comment on whether Kelly is being questioned about Fezell.

"Where did Clyde Kelly get money to hire an attorney after he had signed an oath saying he couldn't afford an attorney?" Fezell asked.

Kelly dismissed Waco attorney Doug Henager, who was appointed by the court to represent him in the burglary indictments.
