McLennan grand jury indicts Waco man in shooting death

A McLennan County grand jury indicted David Lee Williams, 27, of Waco for murder in the March 24 shooting death of Elroy Johnson, 33, of 1200 State St.

Williams, 1124 Houston St., was arrested by Waco police on March 24 after he surrendered at the police station.

Johnson was killed after a disturbance at the Gholson Heights Drive-in Grocery, 1201 Gholson Road. He was shot three times.

Police spokesman Bud Thurman said Williams told police after his arrest that Johnson pulled a knife on him and slashed at him.

Williams said after Johnson pulled the knife, he (Williams) went to his car and got the gun he used to shot Johnson.
