SGT. SIMONS & I were told by WILLIE TOMPKINS that he had seen a girl with DEEB shortly after or during the times of the MURDER. This girl was described as a white female with blonde hair and WILLIE TOMPKINS did tell us her name and that name was DANA DIAMOND. The only information that WILLIE TOMPKINS could give us about DANA DIAMOND was that she was from Houston.

During the investigation in reference to this case, DANA DIAMOND'S name did come up and we did find that she lived somewhere behind the store located at 1423 Herring in a small apartment.

On 9-14-82 at approx. 12:NOON, SGT. SIMONS & I went to the businesses and houses behind 1423 Herring trying to locate DANA DIAMOND. After checking with several people we found that DANA DIAMOND was living in a small two-story house close to 15th & Herring. She was not home when we were there at approx. 12:NOON and we were unable to talk to her.

I contacted a GLENN NAUNANN who is the owner of that property (799-3258) and he did confirm that DANA DIAMOND lived in the bottom apartment.

At about 9:30P, 9-14-82, SGT. SIMONS & I went to DANA DIAMOND'S house. There we talked with her and after hearing her story she did agree to come to the WACO PD to give us a statement. In that statement which was attached to the original report in RECORDS she said that she met DEEB about the first of June 1982. She met him at the RAINBO STORE. DEEB & DANA DIAMOND did go out on two occasions.

DANA DIAMOND did say that after they got to know each other that DEEB asked her to marry him so that he could obtain his AMERICAN citizenship. DEEB told DANA DIAMOND that he would pay for \$500 to marry him. DEEB did not set a time limit on how long the marriage would last. After thinking about the offer DANA DIAMOND did refuse.

DANA DIAMOND did say that DEEB did buy a small amount of groceries for her from time to time. She also said that he was very possessive with her. He told her that he could have the apartment blown up if she did not stop seeing her boyfriend, STEVE, and that would mean that

neither STEVE nor he would have her. We asked her if DEEB ever said anything about the killings of KENNETH FRANKS, JILL MONTGOMERY OR RAYLENE RICE and she said no. She thought for a minute and said that there was something but it probably did not mean anything but that she was in the store one night after the MURDERS and that DEEB told her that he just missed collecting \$20,000 because he had an insurance policy on a girl that was a sister of one of the girl's that was killed and that the girl that he had the insurance policy on almost went with them. He did show an envelope which indicated it was an insurance policy however she was unable to give us the company's name or the name on the insurance policy or the beneficiary.

DANA DIAMOND'S boyfriend is STEVE NOVLAN, B/M, who lives in Bruceville, Tx., 859-5579.

DANA DIAMOND was told by DEEB that he had killed two people before but he would not say where but implied that it was in his homeland.
