BREM asked his mother if he could go & she stated no and when he told FRANKS this information, FRANKS asked him to try and talk his mother into it and that he would call him back. BREM never heard from FRANKS again. TORRES had also informed me that he had picked up KEMMETH FRANKS on 7-13-82 from University High School at 12:15P and dropped him off at his house at 1:P. He stated that TORRES went home and slept and that his sister had told him that FRANKS had called him at approx. 2:P looking for him; however, he was asleep. He stated that the only other time that he talked to FRANKS was at 6:P. We had received information that TORRES had informed a fellow employee that if he had been at the scene an hour earler, that he too would have been murdered. I asked TORRES about this incident and TORRES stated that he id not say this, because he did not find out that KENNETH FRANKS had been murdered until he lent to EICHARD FRANKS residence, after getting off of work on 7-14-62 and that he has not been back at work since, so be could not mave to the parameter of the parameter back at work since, so he could not have told anyone this information.
