house 1705 Clark. When we got to my house, Kenneth,
Jim & Tammy followed me to the door, when we went
 in the other 3 guys come in also, and brought their beer

I made the following statement before me and said "You best do what we say before we build you." I could see that he meant what he said and thought that they were just trying to humiliate me. I took off my pants and Gilbert said "The short one" I started to cry and took off my shorts. I said "Look Gilbert stand me up on the bed and David hit me in my stomach 4 or 5 times knocking me back on the bed, I said "then ask him "let me see your knife" Jim gave David the Buck knife I had taken away from earlier, which had a blade about 4" long with a black handle. I said "then hold down my testicles and put the knife blade to my neck and said "I am going to cut your Adams apple out and eat it" He stood up and Gilbert got on top of me and started slapping my face and choking me to the point of almost passing out again. Then Gilbert stood up on the bed and took my pants and of my pants told me to suck him. I said "no," David said "you best do what he says before I cut you." I started to get up of the bed when Gilbert slap my face and at the same time I felt and saw David hit me on the back of my right arm. I saw the cut but I didn't feel any pain. The cut was about 4" horizontal. Gilbert then said
