On 8-30-82, at 10:30A, I made contact with a MR. WILSON SOCKWELL of Valley Mills Texas, residence phone 932-6173, bus. phone 932-6212, at a Phillips 66 gas station. Conversation with MR. SOCKWELL was in reference to his twin daughters, CINDY and LINDY SOCKWELL, who had heard information of a pickup that KEN FRANKS had been in the night of the murders. This information had been given to MR. SOCKWELL by his twin daughters, who had heard it from another source.

At approximately 11:30A, I did make contact with CINDY & LINDY SOCKWELL at the Valley Mills High School where superintendant BENNY POWERS was present during the interview. The twin sisters, CINDY & LINDY's, dob is 10-19-64, and are in their senior year. It talking to them at 11:30A, 8-30-82, they stated to me that they had heard the information from a JANET McLEMORE who is a white female, dob 8-30-64, who is presently enrolled in MCC. This information had been obtained by JANET McLEMORE from her cousin, DARLENE BLAND, white female, 21yca. The story from CINDY & LINDY was that a friend of DARLENE BLAND's friend had told her that she had seen KEN FRANKS sitting in a pickup with two other subjects and KEN was sitting in the middle, between them, and that when she had waved at KEN, KEN had neglected to wave back. She did say that they were real good friends, and she did not understand why KEN did not acknowledge her greeting, and that they felt that this had occurred at Koehne Park somewhere near dark.

Superintendant POWERS then gave me the name of MRS. BLAND, mother to DARLENE BLAND, where I went to her place of employment at DR. WILLIAMS chiropractic office, in Valley Mills. MRS. BLAND told me that her daughters name was now DARLENE LEDLOW, she was 20yca, and home ph/675-6386 in Clifton, and that she was employed at Central Freight Lines in Waco at 772-2120. She also stated that her daughter had told her something about the incident of this KEN FRANKS being in the pickup with two other subjects. However, she does not know anything about the boy or anything.

At 12:15P I did make contact with DARLENE LEDLOW at Central Freight Lines where she told me that she had heard the story from a KATHY COLLINS, white female, home ph/755-8508, and that COLLINS had heard it from another friend whom she did not know at this time. This is all that she could tell me.

At 1:10P, I did talk to MISS COLLINS who is also employed at Central Freight Lines. She told me that she had been told the same story that I had talked about, about KEN being seen in the pickup with two other subjects, by another friend of hers by the name of PAULA RADCLIFF, of 1920 Tanglewood Street, ph/752-9543, who was employed at the Waco School Administration Office

At 1:45P, I did make personal contact with PAULA RADCLIFF at her home address, and found her to be a white female, dob 2-18-59. I also saw that she did live directly across the street from BOBBY BRIM who had been questioned in reference to this case, also. In talking to MISS PAULA RADCLIFF she did tell me that she had heard the story of KEN being seen in the pickup with two other subjects from BOBBY BRIM, and BOBBY had said that he had heard this from a girlfriend that he knew and that this sighting had been done at Koehne Park, that one day BOBBY BRIM was driving down the street and this girl had pulled up beside him and hollared at him that she had seen KEN earlier the night of the murders and that BOBBY had told the girl to call him at home and that he would listen to what she had to say.

I then went across the street to BOBBY BRIMS house at 1905 Tanglewood where he told me that the girl who had told him that she had seen KEN FRANKS in the pickup with the subjects was a girl by the name MARY PADILLA, whom this officer had talked to earlier. Her home address is 1619 Clark, and home ph/752-5608. However, BOBBY stated that MARY had told him that she had seen KEN in the pickup at Koehne Park and not at 19th & Park Lake Like she had told SGT. FORTUNE & I earlier, when we did talk to her, on July 26, 1982. BOBBY BRIM thought that she had said that the pickup might have been probably silver in color.

I then went to 1619 Clark, and was unable to contact MARY PADILLA at home. I did leave a card on her door for her to call me back. I was advised by Office Personnel that she had called back at 3:30P, while I was out of my office. This call was taken by DET. THOMPSON.

At 3:35P, 8-30-82, I did talk to a JOEN GUTIERREZ, who is father to twin boys, TERRY & JAMES GUTIERREZ, living in Hewitt. The reason for the conversation with him was that information had gotten to us that the twins, TERRY & JAMES GUTIERREZ, had failed to show up for a confrontatio contest at Pinocchio's Game Room on 7-14-82. These boys were regular patrons of the place and would not have missed this tournament for anything, and the proprietor stated that he had found out that they had gone to Dallas on 7-14-82, instead of staying at the tournament, and he thought that this might be something funny, these boys missing the tournament like they did

after the murders. However, at the time that the boys had left, the bodies had not been found, as of 6 o'clock on 7-14-82.

In talking to MR. GUTIERREZ he told me that he did not know where the boys had been at on that day, only that he knew they were not saints, and they do get around and did not take anything from anybody. However, he also volunteered that he has checked the boys to see if they are into any kind of illegal drugs and has not been able to find any evidence of their having any of these illegal drugs in their vehicles, at different times. I did have him to have JAMES, his son, call me, being that he told me that TERRY had since then left to go to California.

At 10P, 8-30-82, JAMES did call and told me that he knew KEN FRANKS, and had met him in Pinocchio's sometime in July, and that KEN had admired his vehicle while they were at this game room, and that KEN had also brought a friend, of KEN's, to look at the car, and had asked JAMES if the car was for sale. JAMES said that he at no time had made any kind of deals to sell the car, but they had asked him how much he would take for it. Since this, the car had been wrecked as of August 14th, 1982. In questioning JAMES about his whereabouts on 8-13-82, and 8-14-82, he advised that they had been here in the city somewhere, he is not for sure, being that it has been so long since that time. He cannot remember everything that he does. However, he stated that the reason for missing the tournament at Pinocchio's was because he and TERRY had gone to Dallas with another friend, to Six Flags, and that the tournaments at Pinocchio's were not all that interesting, being that there was only a \$10.00 prize for winning in the tournament. Also, he said that he did not know anything about KEN FRANKS habits, at all, being that he did not associate with him that much, had only talked with him two or three times. He did then think back and said that he had gone to Dallas on Wednesday, 7-14-82, and returned late that same night, and had spent the night with a friend, whose name he refused to give me to check on it, and then he had gone back on Thursday and the next day the guy, BILL, from Pinocchio's had asked where they had been since they had not showed up for the tournament.

I did ask JAMES GUTIERREZ to have his brother, TERRY, to call me, at which time he did return from California.

At 8A, 8-31-82, I was advised by LT HORTON that he had received a call from SGT. MOORE of Interprise Alabama, who had said that DANNY SISEMORE had been kicked out of the apartments on July 10th, 1982, and had been arrested July 15th, 1982 for skinny dipping in the area lake with

a black subject. Information had been that DANNY SISEMORE was a homosexual. Since then they believe that DANNY SISEMORE is in another City nearby in Alabama. However, LT HORTON had received information Monday, 8-30-82, that DANNY had been seen on Bosque Blvd near Lake Air last week, either running or jogging in the area. As of this time we have not ascertained for sure whether DANNY SISEMORE has been here in the city of Waco during the time of the murders, or if he is here at this time.

At 10:35A, 8-31-82, I did receive a call from MARY PADILLA of 1619 Clark, 752-5608, where I did question her as to the story as to where she had seen KEN FRANKS last on July 13th, 1982. She again stated that she had seen him at 19th and Park Lake at the 7-11 and Chief's Auto Parts. I did tell her that I had received the information from BOBBY BRIM, whom she stated was a real good friend of hers, that she had told him that she had seen KEN at Kosine Park. She then denied this again. However, she did say that she had been in Kosine Park later, approximately 9:30P. However, had not seen KEN at that time. At this time MARY PADILLA was at her employment where she is to get off at 6 o'clock and earlier stated that she could come by and see me at the station and discuss this matter, on Sunday, 9-5-82, at which time she will come and talk to me in confidence about this case.

I did try to contact MR. RICHARD FRANKS in reference to a vehicle that KEN FRANKS was attempting to buy from a subject by the name of JAMES GUTIERREZ. However, answering service answered the phone and I left a message and have not received a call from MR. FRANKS as of this time.
