Under the direction of McLennan County District Attorney, VIC FEAZELL, and Assistant District Attorney, NED BUTLER, officer of the McLennan County Sheriff's Department and officers of the Waco Police Department were able to produce enough evidence that it was presented to the McLennan County Grand Jury on 11-21-83 and indictments were returned on the above four named people.

DAVID WAYNE SPENCE was convicted of the offense of CAPITAL MURDER on 7-3-84 by jury in 54th District Court McLennan County and was assessed the DEATH PENALTY on 7-6-84 by that same jury.

ANTHONY MELENDEZ pled GUILTY in late June of 84 for two offenses of MURDER in relationship to the MURDERS of KENNETH FRANKS and RAYLENE RICE and has been transported to the Texas Department of Corrections for that offense.

Trials are pending at the time of this report on GILBERT MELENDEZ and MUNEER MOHAMMAD DEEB.
