At approx. 2:00P 11-12-82 I went to Ft. Fisher Museum where I contacted LOU BOOKER who was a employee at Ft. Fisher during the summer of 1982 and did have an opportunity to get to know JILL MONTGOMERY. MS. BOOKER and I did talk in length in reference to her knowledge of JILL and RALENE.

MS. BOOKER stated that JILL MONTGOMERY worked for the CETA program during the summer of 1982 for approximately two or three months. She said that JILL MONTGOMERY quit work approx. two to three weeks before she went home to Waxahachie. Said she was very quiet person and a good worker. MS. BOOKER also did state that GAIL KELLEY was also employed at Ft. Fisher and that GAIL KELLEY and JILL MONTGOMERY had a strange relationship. She said that sometimes they would appear to be close friends and then at other times did not care for one another.

MS. BOOKER also brought up the fact without me saying anything about it that she had seen a person known as LUCKY come to Ft. Fisher several times. She also saw GAIL KELLEY and JILL MONTGOMERY talking to LUCKY who is MUNEER MOHAMMAD DEEB. MS. BOOKER said that she did overhear JILL MONTGOMERY and GAIL KELLEY talk to LUCKY and on numerous occasions KEN FRANKS name was mentioned and that there would be a very noticeable reaction from DEEB.

MS. BOOKER said that JILL and RALENE did come to FT. Fisher between 2:00PM and 2:30PM on 7-13-82. JILL MONTGOMERY came by just to say hello to the people that she worked with during the summer. MS. BOOKER said that JILL MONTGOMERY appeared to be quite happy and did mention the fact that she was going home to live with her mother. MS. BOOKER also made comment that she believes that they were wearing the same clothes as was mentioned in the paper after the children were recovered at Speegleville Park. She could not give me any definite description of the clothes due to the fact that the length of time between last seeing them and todays date. MS. BOOKER said that JILL and RAYLENE only stayed for a few minutes and did make the comment that they were hungry and were going to go get something to eat.
