On Tuesday, 10-26-82, DET. SALINAS and I did go to Waxahachie in attempt to follow up on the information received from CAPT. SULLENS of the Waxahachie PD as well as BILL GUNN of the Texas Rangers, in reference to several people in the Waxahachie area that might have some information in reference to this case. Among the people that we talked to was TERESA and GARY LOWE of 109 E. Ross. This name had been given to Texas Ranger BILL GUNN in reference to her possibly being with or around RAYLENE RICE, prior to the murder. At approximately 11A, 10-26-82, Tuesday, DET. SALINAS and I did go to 109 E. Ross where we did talk to TERESA LOWE and her husband GARY LOWE. TERESA said that she and RAYLENE and another white female whom she only knew as EVELYN who now is living somewhere in Arlington or Ft. Worth, were at the lake with several other people on Sunday, 7-11-82. They were at Lake Waxahachie. TERESA LOWE said that at approximately 3P, that they did get into a boat with two white males, one she only knew as UNCLE GEORGE, last name unknown, who was described as a white male, mid 30's, who is going bald. The other white male with a first name of STEVE, last name unknown, who is in his mid 20's. TERESA LOWE said that she could not remember correctly whether or not RAYLENE knew these two people or EVELYN. However, TERESA LOWE did not know these two people and has never seen them since. She said that the three of them skied for approximately two hours on Lake Waxahachie. She said that the only thing that occurred that might have been out of the ordinary was that UNCLE GEORGE and STEVE and EVELYN were in the water, trying to untangle a ski rope, and that RAYLENE and she were in the boat. The boat was drifting towards the shore and that UNCLE GEORGE was near the rear of the boat. RAYLENE, while attempting to keep the boat from being beached, she started to turn the motor on while UNCLE GEORGE was at the rear of the boat. He did cuss at RAYLENE because he was at the back of the boat and the engine had been started and he was afraid that he was almost cut by the propellar. TERESA did say that they did stay in the boat and ride around in the boat after that had occurred and that UNCLE GEORGE did not say anything else about that incident. According to RANGER BILL GUNN, was that UNCLE GEORGE had made a threat to RAYLENE, saying that he was going to kill her, and this is probably where that threat originated.

TERESA LOWE could not give any description of the boat, or any other description of UNCLE GEORGE or STEVE. We asked TERESA LOWE and GARY LOWE if they saw anything else unusual about that event at the lake and she said that she saw RAYLENE with a white male that was in a blue van.

and that was all that she could say other than GARY LOWE had given the information to OFFICER BURLEY of the Waxahachie PD.

TERESA LOWE had known RAYLENE for approximately a year and a half and they had met while both were employed at the Pizza Inn. TERESA LOWE said that on Sunday, 7-11-82, that RAYLENE did not say anything about going to Waco with JILL MONTGOMERY.

DET. SALINAS and I did go back to the Waxahachie PD after talking to TERESA LOWE and try to find out who the white male was that owned the blue van. After talking to officers we did find that the owner of the blue van was a SCOTT ANDERSON, who works at the Ellis County Auto Repair at 407 W. Franklin Street in Waxahachie Texas. Business ph/214-937-4336, and SCOTT's home phone number is 937-3427.

DET. SALINAS and I did go by Ellis County Auto Repair and talk with SCOTT ANDREWS at which time he said that he had known RAYLENE for a period of time while going to school. However, they had never gone out. He did see her at Lake Waxahachie on Sunday, and that they did go get a steak at Kay Bob's steak house there in Waxahachie and he had made a date with her for the next week. He said that he did not see her Monday, and that they did drive around until approximately 12 or so Sunday night.

There was nothing, either through the Waxahachie PD or other sources, to discredit the story that SCOTT ANDERSON had told us.

At approximately 11A, on Wednesday, 10-27-82, DET. SALINAS and I went to Ennis Texas. We had received information from BILL GUNN of the Texas Rangers that JILL and RAYLENE RICE were enroute to Ennis Texas to see two male friends, before leaving for Waco, and that these two male friends were supposed to go to Waco with the girls, following behind them, and go to a party in Waco on 7-13-82. The only name that BILL GUNN was able to get us was one subject was named LYNN, last name unknown, and the other was a RICKY TREAT, or TREET. He was able to find out, however, that they did work at the Leggott-Platt Company in Ennis. I did contact Leggott-Platt the week prior to 10-27-82, and found that the LYNN MARTINEZ and RICKY THREET, did work there.

We were unable to contact RICKY THRETT due to the fact that he was at school at the time. However, we did talk to LYNN MARTINEZ. His home phone number is 875-5249, and his business ph is 875-8271. LYNN MARTINEZ does live on a rural route in the country, around Ennis.

We did question LYNN MARTINEZ in reference to his knowing RAYLENE RICE, or JILL MONTGOMERY, and he said that they did meet RAYNELLE RICE and RAYLENE RICE on the 4th of July at Lake Bardwell outside of Ennis Texas. He also said on July 5th, 1982, that he met RAYNELLE and RAYLENE again, and also met JILL MONTGOMERY. He did make arrangements with them to possibly see them the next week. LYNN MARTINEZ said that RICKY THRETT was not at Lake Bardwell on July 4th or July 5th.

On 7-12-82, LYNN MARTINEZ and RICKY THRETT did go to Waxahachie in RICKY THRETT's mothers white Cutlass. While in Waxahachie they did run into a white female that LYNN MARTINEZ only knew as DEE, and RAYLENE and RAYNELLE RICE. They did drive around, drink approximately two beers. LYNN MARTINEZ said that RAYNELLE RICE did get out of the car and that RAYLENE and the girl DEE did stay in the car with RICKY THRETT and LYNN MARTINEZ until approximately midnight. He said that there was only time that it was mentioned that RAYLENE was going to go to Waco on 7-13-82, with JILL MONTGOMERY, to pick up her check.

While in Waxahachie, DET. SALINAS and I did contact JAN THOMPSON at 100 Dartmouth, who is the mother of JANA SANTOS. While at 100 Dartmouth we also talked to JILLS mother, NANCY SHAW, as well as ROD MONTGOMERY, JILL's father. DET. SALINAS and I did talk to them for approximate 2 1/2 hours in reference to this case. They were unable to give us any other type of information or leads at this time.
