Dear Sheriff Drury:

I came across the recent article about your search for the body of Cheryl Ann Scherer, a forty year old disappearance case.

I was the McLennan County, Texas, District Attorney during the 1980's. Along with Texas Attorney General Jim Mattox, we conducted a grand jury investigation into the confessions of Henry Lee Lucas and his whereabouts during the relevant times. We gathered a massive amount of information.

After I left the DA's office, I represented Henry Lee Lucas on various murder charges across the country. During the mid-nineties, I presented Mr. Lucas for a blood draw for DNA comparison in a Tyler, Texas murder charge. The case was dismissed against Mr. Lucas and the real killer was later apprehended and imprisoned due to DNA. Almost thirty Lucas confessions have now been solved because of DNA. Henry was a big liar but not much of a killer.

This letter is to let you know that the DNA profile of Mr. Lucas is in CODIS and NDIS and can be compared to any DNA on the bank bag left at the scene of Ms. Scherer's disappearance. At least you may be able to exclude Mr. Lucas as a suspect.

I've also enclosed a sheet from the "Lucas Report" we compiled during the 1980's that shows the information we have on Lucas' whereabouts during the relevant time.

If I can be of assistance in any way, please contact me. I wish you the greatest success in finding the perpetrator or perpetrators of this crime.
