At 1:15P Monday 7-19-82 I contacted a ROGER COTTON who is Chief of Police at Meria Texas, same area code as ours, at 562-5385, asking him in reference to a Murder that occurred possibly in their area involving the same circumstances as the one we had here. Chief COTTON advised me that he had no knowledge of any type of Murder that occurred there similar to this one. I asked him about subject ROY DALE GREENE. He stated the name did not ring a bell to him but that he would check his Records and give me a call back. He did give us a call back and stated they had a Murder of a female approx. 5 years ago, but that the guy was still in TDC serving time on a Life sentence on that Murder, but that he could not find anything involving ROY DALE GREENE.

At 2:25P on this same date 7-19-82 I contacted a TIDY LEWIS at 310 Billington, resident ph. 662-3249, work ph. 752-0299. She works at the address of 2100 Franklin. This is a Centox Corporation at that location. She related to me a story concerning a subject that she saw on the film at KENNETH FRANKS funeral. She stated this subject was very weird acting and hung around the bowling alley at Westview, was a loner, pretty well stayed to himself and always saying weird and strange things. I called HOWARD BALL at the KWTK. We set up a showing of the movie so that TIDY LEWIS could observe this subject and maybe get some identification on the subject.

On Tuesday 7-20-82 at 9:35A CAPT. JANUARY, MYSELF and LARRY ABERG went through the personal effects and papers that KENNETH FRANKS father brought to the PD. These were papers and things that were found in KENNETH FRANKS personal property in his room. We made a list of names and phone numbers, that's all that was in the property was names and phone numbers and began a trace down of each of these names and phone numbers.

The first subject contacted was at 11:15A on this same date 7-20-82, her name being CHRISTY HOLLINGSWORTH who lives at 3608 N. 24th, ph. 755-7667. CHRISTY was an associate that went to school with KENNETH FRANKS at Waco High School, her DOB is 12-20-65. She related to us that she knew KENNETH FRANKS fairly well, that she had at one time considered dating him, that she liked him this much. Her parents refused to let her do so. She stated that some of the associates that KEN FRANKS ran around with was KELLY KOWAN, a PATRICK TORRES, BOBBY BREN and a GAYLE whose last name she did not know, that had a peach

colored T-Bird. I later found this to be a **GAYLE KELLEY** in the Peach colored T-Bird **QZM-942** belong to a **PAULI** who was a friend of **GAYLE**. She stated that she knew that **KENNETH FRANKS** did use grass and from time to time taken a few pills. She had not seen him in approx. two or three weeks prior to **KENNETH'S** death. She only knew **JILL** casually, did not know the other girl, **RAYLENE RICE**, at all. She stated that **GAYLE KELLEY** was the last known girlfriend that she knew of in reference to the subject **KENNETH FRANKS**.

At 2:00P this same date 7-20-82 I met **TIDY LEWIS** at the Waco Police Dept. **MICHEL** and **LARRY AMER** carried her to **KWIX** where we met with the news director **HOWARD BALL** and he showed the film to us of the funeral of **KEN FRANKS**. **TIDY LEWIS** picked out a white male with a large bushy mustache. I recognized this subject to be **LARRY WEBB** W/M 27 years old, lives at 1912 Colcord, ph. 752-8780, works as an orderly at Providence Hospital at 753-4551. I knew this subject from working security part time at Providence Hospital and was able to contact him at that location and find out the reason for him being at the funeral and what relationship he had with the **FRANKS** family. The subject **LARRY WEBB** related to me that he had known the **FRANKS** family since he was 12 yoa, that he had been around **KEN FRANKS** ever since he was a young fellow and that **MR. FRANKS** had been his counselor at church when he was just a youngster growing up and that he felt real close to the family and felt that he should go to the funeral. This is the reason that he was at the funeral and the only reason and this was his only connection with the case.

At 3:15P a **GAYLE KELLEY** W/F 18 who lives at 1500 College Dr. Apt #218 along with **PAULI DEIS** W/F 17 who lives at the same address, came to the PD and discussed this case with several Officer's who questioned them. The subject **GAYLE KELLEY** ran down most of the same names that **CHRISTY** had given me in reference to the associates of **KENNETH FRANKS**. **GAYLE KELLEY** did add another name to it, a **LAURA MCDONALD**. She stated that **LAURA** and **KEN FRANKS** had dated at one time or another, that **LAURA** supposedly still lives at the Waco Methodist Home. I have been unable to contact **LAURA** till this date.

At 8:15A 7-22-82 I contacted a subject RHONDA MICHELLE EVANS W/F 2-25-66 who lives at Rt. 1, Artell, ph. 993-4341 and RHONDA related to me that she had lived at the Methodist home and had left around March. She had known this subject KENNETH FRANKS, that he had dated JILL MONTGOMERY. She stated that she and JILL MONTGOMERY were at the home at the same time and that one time she had ran away with JILL MONTGOMERY, this being in November or February. She could not remember of 1981. She also related to me that LAURA MADDERAX who lived at the Methodist Home was the very last girlfriend that she knew of that KENNETH FRANKS was dating. She stated that LAURA MADDERAX was very very secretive in all that she did, had had made threats toward JILL because she stated she was going to beat her up because she was jealous that JILL was dating KEN FRANKS whom she liked. The last time RHONDA MICHELLE EVANS stated she saw the subject KEN FRANKS was Tuesday morning at summer school at University High School. She stated that she had left around 10:00A and that was the last time that she had seen KENNETH FRANKS alive. When asked if KENNETH FRANKS she knew was involved in any type of drugs, she stated that she knew he had smoked weed and took a few pills, that he did sell this stuff or had it available if anyone should want it and she knew that he made most of his scores at Waco High when he made his buys but she was not sure who he would buy the materials from. JILL was last seen by her at Summer school also on June 3rd. JILL started to summer school only when a few days and then dropped out and she did not know RAYLENE KICE at all. When asked of associates she gave the same names, except she added a subject named HENRY JOHNSON, no age or dob or address known on any of these subjects, Subject HENRY REYES, BILLY ANTHONY and that these subject's all went to Waco High and that they all lived at the home during the time KENNETH FRANKS was there.

RHONDA EVANS now lives with her foster parent SALLY TUCKER in Artell. She works for Heart of Texas Council of Governments. She did relate to me that the only dealer that she knew was a white male 16 to 17 yoa who went to Waco High whose name was MICHAEL WILLIAMS. She did not know his address or how to get in touch with him. I tried to contact the subject JANET BROOKS at 799-2683, got a recording of the disconnected number. Also I tried to contact the name SHERY at 666-3403, got a recording of disconnected. There was also a phone number #755-6931, this also got a disconnected number.

The other people I have contacted with had previous appointments in all, when they are contacted and talked with, I will make a supplemental report as to the information which they give me.

I had a white female call me on the telephone. I did not interview her in person and she stated that on Tuesday 7-20-82 that she and her boyfriend were in Koehne Park at 9:15PM. This girls name was [redacted] who lives at 808 Rambler #7, has no home phone. She works for the Red Cross on Mondays from 4:00P till 7:00P. She stated that her boyfriends name RICKY PATE who lives at 804 W. Billington 662-2908, and himself [redacted] at Koehne Park and saw the three subject's in the orange Pinto. She stated she knew it was around 9:15 because they had just locked at her watch prior to them driving through. She stated the orange Pinto entered Koehne Park, drove down to the beach area or the old 6 landing, down below the hill, stayed down there for a while. She stated she and RICKY PATE went to get something to eat, were gone approx. 20 minutes. When they came back the orange Pinto was still down at the bottom of the hill. She further told me that the orange Pinto drove by, she saw KEN FRANKS sitting in the front seat passenger side, she did not know the two girls at all that was with him. But she does know KEN FRANKS because he use to date a girlfriend of hers, a MICHELLE LEWIS who lives at 810 Rambler #5 and this is how she got to know KEN FRANKS. She stated she waved and spoke to KEN FRANKS, said "How you doing." He said "fine". They drove on around through Koehne Park around to the Circle area. She did not see them or the car leave. She stated she and her boyfriend PATE left sometime between 10:30 and 11:00. I contacted RICKY PATE at his home phone. He stated he did not know any of the subject's and that he got home around 11:15P, stated that DENISA did tell him that she did know the car and she recognized the subject's. He told me that he paid no attention to it and did not know any of the subject's even if he had paid attention to the car.
