On 2-23-83 we received information that a JAMES RUSSELL BISHOP had been arrested in Coronado, California for Kidnapping, Sexual Assaults and Attempted Murder on two young females.

The females, one was 17yoa and one was 15yoa, were abducted by gun point off of a street in Coronado. They were driven around by JAMES BISHOP for several hours. They were forced to blind fold each other with plastic trash can bags. JAMES BISHOP took the two females to the beach where he sexually assaulted both. He then made them walk into the surf where he fired at them with a 380 automatic pistol, striking each female several times.

JAMES BISHOP left the girls in the water for dead and returned to his residence, by an unknown means, because his pick-up got stuck in the sand.

The police authorities were notified as one of the females walked to the roadway, where she was picked up and taken to a hospital. The girls did identify JAMES BISHOP as their assailant.

Lt. Horton, Detective Salinas and Sgt. Baier left D-FW airport at about 10:00PM on 2-23-83, to fly to Coronado, California, to talk to JAMES RUSSELL BISHOP about our case. We talked with Officers of the Coronado Police Department about their case on BISHOP and possible links to our case. They informed us that BISHOP was scheduled to be arraigned at 2:00PM on 2-24-83 and that once he was arranged we would probably not be able to talk to him. That is when the decision was made to travel to Coronado, California and talk with BISHOP in the AM hours of 2-24-83.

THURSDAY - 2-24-83

8:30AM: We went to Coronado Police Department to make arraignment to question BISHOP about our case when we received a call to go to the San Diego Court House for the arraignment of BISHOP. We were told by their District Attorney's Office that we could not talk with BISHOP.

10:00AM: San Diego Court House
Formal arraignment of BISHOP - Bond was set at \$500,000.00 and Hodge Crabtree was appointed as his Defense Attorney. During arraignment, District Attorney Hugh McManus did mention that authorities from Texas were investigating BISHOP. BISHOP did not give an outward expression of surprise or disbelief that any of us could detect.

11:00AM: Discussed our chances of talking with BISHOP again with Hugh McManus and were again told we could not.

2:00PM: Talked with Ed Hodges about his interview with the victims and their physically & emotionally able to handle us questioning them. Hodges said that both were in very critical condition and that the doctors would not let a group of people in. We therefore relayed questions to the girls thru Hodges.

6:00PM: Interviewed with Both Patricia Bishop and her mother, Madelyn Christian.

FRIDAY - 2-25-83:

9:00AM: Contacted our District Attorney's Office in an attempt to get some help in avenues to pursue to talk to BISHOP and a tentative deal that we could cut with BISHOP and his attorney, if in fact BISHOP did want to confess to ours.

11:00AM: Reviewed all of the evidence that the Coronado Police Department had confiscated by search warrants on the residence of BISHOP and his vehicle.

Detective Salinas went with Inv. Joe Maggio of Coronado Police Department to BISHOP's residence to aid the apartment owner to remove BISHOP's personal items so that someone else could move in.

We took pictures of the knots in the shoe string that was used to tie one of the girls hands.

2:00PM: Went to their vehicle storage lot where we took pictures of the vehicle and looked through it for any evidence.

4:00PM: We talked with Hodge Crabtree in an attempt to talk with BISHOP and to try to get some indication from Crabtree of BISHOP's involvement in our case.

We obtained copies of reports by both the Coronado Police Department as well as the F.B.I.

We talked again with Inv. Ed Hodges about his interviews with the victims.
