KEBANA REED has known DEEB for about 3 years. She worked at K-MART off IH35 at that time. DEEB would come into K-MART and make conversation.

After leaving K-MART she was employed by a radio station in Marlin, Tx. selling advertisements. She quit the job sometime during the summer. She began working at TARGET STORES, INC. when they opened up in either OCTOBER/NOVEMBER 1981. Between the time that she worked at the radio station and the time she was employed by TARGET STORES, INC., about 3/4 months, she was supported by her sister, CHRISNA & DEEB. KEBANA REED said that DEEB did give her money to make car payments and rent payments several times during those 3/4 months period. She was very evasive about the total amount of money that DEEB had given her but she said that she never took over \$200 at any one time. She also received money for groceries and was seen SGT. SIMONS and WILLIE TOMPKINS and others in SKAGGS SUPERMARKET with large amounts of groceries that were paid for by DEEB.

DEEB asked her several times to marry him but she refused to. She said that she thought of DEEB as a friend nothing more. KEBANA REED said DEEB was very possessive. DEEB would follow KEBANA REED around the city. An example of this was when she went to work for the Water Dept. at 1000 Columbus she did not tell DEEB because she did not want him to bother her. But one day she saw DEEB outside the building waving at her. KEBANA REED also said that DEEB would come over to her apartment after she got off work between 11:P/1:A and stay for a couple of hours before leaving. She also said that at times she would look out of her apartment as early as 3:A and see DEEB sitting out in the courtyard area of her apartment complex looking at her apartment.

KEBANA REED said that DEEB was at her apartment about three days after the MURDERS and that she, DEEB and her sister, CHRISNA were talking about the MURDERS when DEEB told them that the girls had been in the store earlier in the day of the killings and that he was glad that KENNETH FRANKS was dead because he used foul language as well as used marihuana. In this conversation DEEB was referring to the two girls that were killed at the lake and that they were in his store at 1423 Herring prior to them being killed.

CHRISNA REED told SGT. SIMONS & I that DEEB told her and her sister that he was glad that

KENNETH FRANKS was dead. DEEB also told them that they shouldn't talk about the MURDERS because they might be in danger and that the MURDERS were not what they appeared to be.

CHRISNA also said that DEEB would come over late at night and also follow KEBANA around. She also said that DEEB was very possessive towards KEBANA and would become upset when there was another male over at the apartment. KEBANA REED did tell SGT. SIMONS & I that DEEB did tell her that he would kill anyone that she went out with. KEBANA REED did take it as a threat and was scared to date other people.
