On 7-21-82 I contacted Ft. Worth Police Dept. and contacted a subject by the name EARL BROWN at area code 817-334-1212 and he stated to me that he did know the subject ROY DALE GREENE, that he had been involved in a Murder case with this subject, that it occurred in August of 1966. He stated that he and another fellow had abducted two male's and a female, had carried them off out and they had shot the two boy's in the head, had stabbed and strangled the young girl after raping her and abusing her. He stated that the subject ROY DALE GREENE was given a lighter sentence because he had turned states evidence and testified against his partner, being a subject by the name of McDUFF. He told me that McDUFF had done most of the killing, that he had shot the boys in the head and that he was the one convicted of Capital Murder and is on death row at this time. Upon further checking I found that this ROY DALE GREENE, W/M 35 yea, dob/11-22-47 has been employed by the city of Waco for 17 months as a janitor at our city hall. Subject has been seeing MEME according to his application, in talking with the subjects counselor, DEBBIE COLLINS, ROBBIE PORTER. He lives at 1819 Herring Ave. Apt #5. MR. BROWN further related to me that they have a complete set of prints and photos on ROY DALE GREENE at the Tarrant Countys Sheriffs office should we need it. They have been unable to locate the case history involved ROY DALE GREENE. They have checked their files and also the District Attorneys office and apparently they can't locate the photos and the case history in regards to that. He stated should he locate it, he would give us a contact phone call and we could pick up a copy of the report should he locate it. As to this date he has not called to tell me whether or not he found the case involving this similiar murder that occurred in Tarrant County. Subject ROY DALE GREENE is from Marlin Texas, his mother being a HELEN WILSON who lives at 306 Durr, 817-883-5947. The subject use to be a patient or work, I have been unable to ascertain at Rusk Institution. His boss was a GLEN HUGGINS. He worked as a kitchen attendant. His military status was 4-F and the reason for his 4-F status was mental illness. His Texas drivers license is #01532182. We have submitted this number and obtained his drivers license picture from DPS in Austin and identification type purposes.
