At 8:30A, this date, 7/20/82, I received information from Det. LUEDKE that a MR. ARTHUR MARICLE who had given me information a day prior in reference to a RICHARD & JOYCE ROBERTS of 331 N. 10th, had called again giving information on a LAMAR DUNN, who is a W/M, 48yos, who wears a bowboy hat. MR. MARICLE stated that DUNN hangs around the lake area and drives a '68 ford van or a panel van and stays with his girlfriend, DEBBIE CARMICHAEL, at 1800 Columbus. I have since then found out from SGT. SHERRILL who read the report on ARTHUR MARICLE and stated to me that he remembers ARTHUR EUGENE MARICLE had been charged with Sexual offenses. We then looked in a card where we had run ARTHUR MARICLE on a polygraph on 1/6/69 in reference to a Rape of a child. I then checked ARTHUR EUGENE MARICLE's record and found him to have DOB of 7/18/43, physical description is 5'11, 180 lbs, with red hair. SUBJECT has PD #9684. It does show the driver's license 8211296, and in checking his record found him to have been examined on a Rape of a child on 1/6/69 under case #69-00029. Also showed him to be examined on a rape of a child on 2/6/69 under case # 69-00029. Also shows that he was indicted for Rape in 1962. This SUBJECT will be checked on more closely and as to where he lives.

At 8:40A, 7/20/82, I talked to a ROGER SHERMAN, 7/20/82 of 3431 N. 29th, 753-1284, stated that approximately two weeks before the murders, that he had been at Koehne Park at approximately 1:30 in the AM and had been asked by TAB HARPER who he has known before, if he wanted to go on Elm Street and pick up a whore. TAB then told ROGERS that if he would hide in the back of the van that they would take her down to the River and kill her. ROGERS then made an excuse and got away from HARPER, making an excuse that they had to go and rest for tomorrow's work. Being that I had scheduled a BECKY DESMARAIS for a polygraph at 1P, this date, I made contact with a LEE ANN HOGKLAND in Longview Texas, 214-757-8853. In talking to LEE ANN, I asked her if the girl that had given her the information of the Oodise being found at the Speegleville Park before noon Wednesday, 7/14/82, was a girl by the name of BECKY. She then admitted to me that it was. That she knew BECKY and had told her that a SUBJECT HARPER had made the comment to her that he knew where three bodies were.

Previously I had interrogated LEE ANN HOGKLAND at her home and she had denied any knowledge of any knowledge of anybody telling her anything.

Town West Center on Valley Mills at approximately 7:30P. Upon 7/14/82. This was still time prior to any news of bodies being found at the lake. They were contacted by BECKY where she made this comment. SGT. FORTUNE and MYSELF then went to the fourth house on the east side of the street on N. 17th, south of Bosque. The house is described as a white house with grn and white window shades. Did make contact with GAYLA SCOTT who is a W/F SUBJECT, 17 where she told me that she does not remember anybody talking about any bodies being found at the Speegleville Area at that time. She does remember being out there with LEE ANN. However, there were so many different kids up there at that parking lot that she does not remember even a girl meeting the description of BECKY.

At 10:15A, I made contact with a DONNA OLSEN of 707 Elizabeth, 662-4163, employed at the HEB store on Bosque and Valley Mills. She tells me that she had talked to MR. FRANKS at the funeral home on Friday, 7/18/82 and that she thought it strange that MR. FRANKS kept harping on the fact that he had advised KEN, his son, that if he ever got into trouble, to stick the keys in the seat. That that way people would not be able to get to his house or his motorcycle. Also stated that FRANKS did have a boat, some sort of fishing boat, months ago. Because MR. FRANKS had taken KEN and a friend of his skiing before and she had noticed that the boat was not at his apartment house that day when she went to try to visit him. DONNA OLSON will be contacted by SGT. HOLSTIEN for an interview as to what she knows about KEN FRANKS.

At 10:35A, I received a call from the Rainbo Drive In store which is at 14th and Herring. The call was from a MIKE SUTTON who is a W/M, 18yoe, 6'4", 175. This SUBJECT is staying at 1123 Proctor, 755-6408, with a DAVID SALAS who is a H/M, 45yoe, who works at the home as a maintenance man. MIKE said that he had seen a guy named TONY drive in a blk cutlass or some type of car like that and he remembered at that time that TONY had had a fight with KEN FRANKS about four months ago and that it had taken three guys to pull TONY off of KEN. TONY had then made the statement, "The next time, I'll kill you" or he said, "The next time I'm going to kill you. His description of TONY is that he is 18-19yoe, 5'8-5'10, 165, muscular build. He gave me the license number on the car as MIT-38. I did run this number through the computer and it came back registered to a MARY C. RUSSELL at 1905 Tanilwood to a 74 Pontiac two door. This is the same address where a CHRISTOPHER BREMM also lives which has been in-

terrogated by Detective NICOLETTI.

I did find, from MIKE SUTTON, that he had just gotten out of the Methodist Home about a week & a half ago. Possibly around July 7th 8th. I had not talked to SUBJECT TONY as of this time. I will make arrangements to contact MS. MARY RUSSELL, to see if this TONY is a relative of hers. Being that he does have the same address as she does.

At 11:15AM, 7/20/82, I received information from BONNIE GARNER, a known acquaintance who advised me that a BOBBY ROSS, who is sheriff of Corsicana could have information pertaining to our case or to ask him about a girl's body that had been found last year stabbed to death between Corsicana between Corsicana and Blooming Grove. This could have some bearing on our case. I have not made any contact with him as of this time.

At 12:50PM, I was contacted by Attorney JOE LAYMAN, who stated to me that he had information from a client of his that had seen a Black van, late model, which had been involved in moving something for his client. I then had him to have his client to call me where at approximately 1:45PM, I was contacted by BILL ALLISON, 753-0438. He stated to me that another friend of his had come in contact with a 73 to a 76 dark colored van which had a rectangular window on the passenger side of the van. No windows on the driver's side. He stated that his friend was in Valley Mills looking for a joint approximately two weeks before the murders and that the SUBJECTS went ahead and made the contact. The SUBJECTS wanted him to follow them to 0 6 which is the circle at Koehne Park. His friend is a MARK WILSON who does not have a phone. MR. ALLISON said that he would make contact with MARK WILSON to have him to contact me about more specifics on the people in this van being that he will be able to recognize these people if he sees them again, possibly from photographs.

At 1:50PM, I had BECKY warned by Justice of the peace Q.Z. Valentine with her parents being present. After this she was administered the polygraph test by SGT. SHERRELL, where after conclusion of the test at approximately 3P, I was advised by SGT. SHERRELL that she had not run a true chart. However, he was unsure if she had lied to all the questions that he had

asked pertaining to the case or whether she was just deathly afraid of something.

I then did talk to BECKY after the completion of the test where I tried to get her to be at ease about the incident and tried to get us any information that could be pertinent to our investigation. However, she still persisted that she had only seen TAB HARPER between 8:45 and 9PM on Wednesday night, 7/14/82 after the bodies had been located by our dept. However, still prior time to the news being aired over the radio.

At 3:20P, I was contacted by MR. LITTLE of the parole office who stated to me that he had a new parolee by the name of JIMMIE COLE TOLIVER who is a W/M, 7/23/45, 5'10", 180 lbs. He stated that this SUBJECT is staying with his aunt at 601 N. 3rd in McGregor, 840-3480 and that when TOLIVER had come to check with him approximately 2 days old and he could have gotten them over the weekend. This SUBJECT is a new parolee.

I then received a phone call at approximately 4:27PM, 7/20/82 from a TRUKETT JOHNSON who is a W/M, 41yrs, 754-4295, employed at the Dept. of Human Resources, 756-6111 and also employed part time at the 7-11 store at Valley Mills and Cobbe on Mondays and Fridays.

He stated that he had been employed Monday, 7/19/82, on 11-7 shift which extended on to this morning, 7/20/82. That he had been confronted by a W/M SUBJECT at approximately 4A this date and that the SUBJECT was described approximately 20yrs, 5'10", 180 pounds, w/short hair cut into a barr. Sort of like a marine hair cut and that the SUBJECT had on a bla bandanna tied around his forehead. He stated that the SUBJECT had asked him if he could polish his shoes or his boots in the front of the store. When he had been told okay, he then had turned around and asked him, "What do you think about my brass knife"? And showed it to MR. TRUKETT JOHNSON. MR. JOHNSON described the knife as a 5 - 6" blade, about 1/2" thick, sharp on one

He also stated that the man had identified himself to him as JIMMY DON LEWIS. After this was done, he then asked MR. JOHNSON "what else have you heard of the murders" which MR. JOHNSON replied that he had not heard anything further. Then the subject LEWIS made the comment "whoever did it should be put to death". Further conversation revealed that LEWIS stated he had been released from the Marines approx. 4 months ago and he also does ride a motorcycle possibly a Kawasaki.

I then did check records on JIMMY DON LEWIS and found him to have PD #27601. Date on 1-10-81 for some kind of Assault offense. However, it shows him to have neck length hair and acne on his face.

At 4:50P I received a call from Temple Police from Officer CLINE who told me that he had talked to a girl by the name of LIBBY who might have some information to our case. She remembered something about a homosexual being killed in north of Waco who had been stabbed repeatedly and his throat slashed. I then had him to see if he could get a hold of LIBBY and have her call us in reference to this incident. At 5:12P LIBBY called me and identified herself as ELIZABETH PIERCE of 525 Phoenix in Temple 774-9207. She stated to me that she was watching t.v. with her Aunt where she had seen a man on t.v. during the funeral filming that she knows to be a homosexual. She described this man to be 5'7 to 5'10, blonde frizzy hair, a large nose, late 20's or early 30's. She stated she has met this man before at the Westview Bowling lanes and that she has also seen him around the flea markets at the Circle. She stated that this subject had been hanging around the Circle when this homosexual had been killed approx. 8 months ago north of Waco. However, the only homosexual that I remember being killed north of Waco was at Elm Mott and he had been shot with a rifle at close range. This case is not worked by the county, it has not been solved as of this time.

At 9:40P 7-20-82 I did make contact with JOSEPH CHAMBERS by public service who is the witness to finding the bodies at Speegleville. I asked him if he would come down to the Police Dept. on 7-21-82 to discuss the case with him and the finding of the bodies and he advised that himself and SIDNEY SMITH would be in my office at 8:30A 7-21-82.
