DET. SIMS advised me that she had been told by some of MR. FRANKS relatives that a subject frequented this place who was known to participate in some type of Indian rituals. ~~Maple~~ This spot was approximately 50 yards from the place where it appeared the bodies had been found. We were not sure at the time of our investigation if the spot we had found was where the bodies had been found, for sure. Therefore, the 50 yards is only an estimate of the place where the tree is. We did find several pieces of possible evidence at the scene, and we did take it and tag it and place it in the property room. Pictures taken at the scene were;

- #1 of the entrance, showing the tree
- #2 of a piece of rubber in the drive, bicycle tube
- #3 shoe hanging on the tree
- #4 nail and markings next to the shoe
- #5 second nail on the tree
- #6 overall tree on the shoe side
- #7 backside of the tree with "I want to suck a dick" written in what appeared to be chalk, on the tree.
- #8 holes in the side of the tree
- #9 close up of the holes
- #10 curtains found on the ground
- #11 red siphon hose, possibly refrigeration hose

- #13 suntan lotion bottle
- #14,15 #16 glasses, brown in color w/clear lenses
- #17 a pair of white hip hugger type panties with the crotch torn out
- #18 cigarette lighter under the tree
- #19 washcloth
- #20 message on the tree that said, "If you want a good blow job", and then gave an address
- #21 rope hanging in the tree
- #22&23 stained leaves at the base of the tree
- #24 wire in the tree
- #25 coat hanger in the tree
- #26 green shoe string hanging in the tree

There is a total of 26 pictures taken. Also pieces of some of these items were taken as possible evidence. This will be the rubber tire tube, the shoe on the tree, one piece of the curtain found on the ground, siphon hose, handkerchief, suntan lotion bottle, the glasses and the lens the panties, cigarette lighter, washcloth, rope, the green shoe string and then several species of leaves and sticks with some substance splattered on them.
