On 7-23-82, at 8:15A, I received information from SCOTT JOHNSON of 740 Westview #38, ph/776-2595, who had given me information prior, last week. He stated that he had heard that a ROBERT SPIKES had seen a black van and that the people in the black van were arguing with the people in the orange Pinto at Koehne park on a Tuesday night. He did tell me that he doesn't know ROBERT SPIKES phone number. However, he was going to try to get SPIKES to call me. This conversation between SPIKES and JOHNSON was supposed to have occurred at 4:30P, 7-22-82.

I did find a ROBERT KEITH SPIKES, at 2205 Pine, ph/754-6591. I did call the ROBERT SPIKES at 9:50A, 7-23-82. He then told me that he had been told this information by a TONY SHAW of 2607 Stewart Drive, ph/753-2020. ROBERT SPIKES told me that TONY SHAW had told him that a guy named RUSTY had talked to a BECKY, earlier Wednesday morning, and that the guy who had bragged about the bodies in Speegleville Park was a guy by the name of KEN. However, he later stated that the name was TAB and not KEN. Believed to be TAB HARPER. This is all the information that he had and this was just hearsay from other people.

I then made contact with a TONY SHAW, at 10:20A, and this was at 2607 Stewart Drive. He told me that a RUSTY ESCOTT had been the one who had said this information and that he had been told this by RUSTY ESCOTT himself, that he had talked to a BECKY DESMARIAS, Wednesday morning. So this again was found to be hearsay from the other people and RUSTY ESCOTT has already been talked to by DET. NICOLETTI.

At 10:05A, I made contact with a TERRY BART BARRETT of 202 Ramona, Hawitt, home ph/666-3588, business ph/776-8000, ext. #295. MR. BARRETT told me that he had gotten to the park at approximately 6:45P, 7-13-82, also which was Tuesday, the day that the bodies were found missing, and that he had gone to the loop, to the left of the Koehne Park entrance, and that he saw the orange Pinto parked facing the water. He also saw the two girls, a blond and a b*Uetta. Shortly afterwards a blue Chevy, about 1969-70, faded blue w/a black vinyl top had pulled up to them and they talked together for a second or so and then drove off. He describes the white male driver of the blue Chevy as a white male, 19yoa, with brown hair, and fair complexion. He also stated that there was a beat-up white van with a pair of boots on the ground nearby. One boot was on the right front of the van, and the other boot was next to a table. The van was parked to the left of the Pinto. MR. BARRETT had parked between the Pinto and the van. He stated that the girls were just talking and he saw no one in or near the van. He stated

he was there approximately 30 minutes, and that he remembered the people from seeing their pictures in the paper, on Thursday.

I did call a SHANNON McCAFFREY, of 1296 Woodland West, ph/776-6073. This was at 11:40A, 7-23-82. MISS McCAFFREY told me that she and her family had been going under the twin bridges towards the Midway boat ramp and that they had seen a boat, running parallel to them, with no running lights on. She stated that she is familiar with boats and this appeared to her to be a large V hull type boat with an outboard motor. She stated that at approximately 10:15 or 10:30 they had loaded up at Midway Park, and that while they were loading they lost sight of the boat with no running lights on.

I then had talked to a KAREN HOSKINS, of 1001 Fisher, in Bellmead, ph/799-8483. Work number/ 752-8381, at Ram Aircraft. She tells me that while she and a companion of hers had been at Midway Park that they had seen a boat loaded up which did not have running lights on, when they were coming to the loading ramp. She describes the boat to be a brown metallic color, with a brown/gold pickup pulling a boat trailer. Three subjects, the only two described was a white male, 5'7", 160-70, curly brown hair, medium length. Also, another subject was 5'5", slender built, and straight hair below the ears. Had not seen the other subject.

At 12:40P, 7-23-82, I was contacted by a PATTI DIES of 1515 College Drive, #218, where she had been broken into at her apartment. Police report had already been made on a burglary at her apartment by DET. NICOLETTI sometime Tuesday, on 7-20-82. This PATTI DIES is supposed to be a witness or know some information in reference to these murders. However, she is not talking. I did try to talk to her again in reference to this. However, she would not volunteer any further information. The case made on the burglary on 7-23-82, has been referred to this case.

I did check with PATTI DIES supervisor at the Army Recruiting, with MR. STANFORD, who told me that PATTI DIES had asked to be off around 11:50A, 7-23-82, and that she had a Police appointment at that time. However, all detectives that were working on this case were not aware of any appointment to be conducted with PATTI DIES, and it is believed that she took this excuse to be off for a few hours in the afternoon, and then found her apartment had been broken into. However, this has not been verified.

In the late afternoon, approximately 4P, 7-23-82, I was contacted by STEVE TURAGE who stated that he had come to the funeral Saturday of KENNETH FRANKS. While he was there he had talked to a girl by the name of MARY VADILLA, who is 17yoa, going to Waco High, and this girl had told him that she had seen KEN and the two girls get into a van, and that is all the information that he had to give us in reference to this case.

SGT. FORTUNE and myself made contact with MARY ELLEN VADILLA, at 12:05P, 7-26-82, and found her to have a dob of 2-9-66, at 1619 Clark. She tells us that she saw KEN at the 7-11 store at 19th & Park Lake at approximately 9P on 7-13-82. That KEN was talking to a subject or a female in a silver colored pickup in front of the Chiefs Auto, to the left of the 7-11. She stated that she had been driving by, on N. 19th, with a friend of her uncles, and that she had hollared at KEN and he had appeared to look towards the street on N. 19th. However, she does not think that he saw her.

She also stated that a girl by the name of CHRISTY HOLLINGSWORTH, who is a 16 year old female of 3608 N. 24th, ph/755-7667, might have some information for us. However, CHRISTY had already been talked to by DET. SGT. HOLLY HOLSTEIN, prior. Therefore, she was not talked to again.

At 4:55P 7-23-82, I also talked to a KENNETH ADKINSON, white male, 8-3- . He was supposed to have come and given us information prior, when this case first started the 15th, and he stated that he had heard only that the kids were going to a party somewhere near Woodway, past Hwy 6 and Bosque. I also did ask him if he knew a DANNY SIDEMORE. He stated that he did know him but hadn't seen him in awhile. He said that if anybody knew if SIDEMORE was in town to talk to a CHRISTINE HART, 17yoa, at the home.

A check was done, today, 7-26-82, and SGT. HOLSTEIN talked to a CHRISTINE HART and was told that she had seen DANNY SIDEMORE in front of Burger King at Valley Mills and Wooded Acres, approximately 3 weeks ago, and had not seen him since that time.

I received a call again from a TERRY BARNETT who had given me information of him being at the Park, late, or early 6:45P, 7-13-82. He told me that I could talk to a JOHN HENDERSON, ph/662-2965, and that he had found out that HENDERSON was there, also, at the same time. However, as of this time I have been unable to contact JOHN HENDERSON to check out his story.

At 1P, 7-24-82, I was contacted by a MIKE McQUEEN from Robinson, where he stated that he had been skiing with a female, now known to me as KAREN HOSKINS, and that they had seen an orange Pinto driving up and down the ramp several times, during the two hours that they were out of the water, talking. He told me that MISS HOSKINS would have more information for me in reference to this. He also told me that he believed he had seen the boat come out of the water between 10:30 and 11P, to be a brown color with a V hull, and three white subjects in it. Also the truck was a dark color, where it appeared to him at night.

I did ask MR. McQUEEN if he would consent to a hypnosis session with DET. LUEKE if needed to for him to remember more about the incident that he had seen being that they believed that the orange Pinto that they saw with a blond headed girl there could possibly be the same one involved in this case. I did advise them at this time that we could probably set up a hypnosis session on 7-28-82, sometime in the morning. He stated that he would be awaiting my call to find out if he was needed, after me talking to MISS HOSKINS.

This am, 7-26-82, I talked to MISS KAREN HOSKINS at 8:35A, 7-26-82, where she told me that she had been at the Lake at Midway Park with MIKE McQUEEN and that after they had pulled the boat out of the water, they had pulled it up the ramp where the boat could drain. Shortly afterward they had been sitting there, about 9:30 or 9:45, and that she had seen an orange Pinto drive down to the water edge, turn back around, sit awhile and then leave. She stated that there was a blond headed girl driving the car. She had left for about 5 minutes and went up the hill towards Midway Park and that the car had left and gone up the hill towards the store and stayed about 5 minutes. Later came back and stayed about 15 minutes, parked up by the dumpster on the righthand side of the boat ramp, and parked again for about 10-15 minutes. I showed MISS HOSKINS a picture of RAYLENE RICE and she stated that the girl that she had seen driving the orange Pinto looked very much like RAYLENE. I also showed her a picture of the car, which was in black and white, and she told me that the car was definitely the car that she had seen at Midway Park. She further stated that the third time that the girl in the orange Pinto came down to the boat ramp was approximately 10:15 or 10:30P, and that she had come and parked again and then a black and silver pickup had pulled up to the boat parking, and a boy and a girl had gotten out and walked towards the Orange Pinto and talked to the blond headed girl for about

5 minutes. Then they had gone back to the pickup and left. The girl had stayed another 5 minutes later, and then she herself had left, going up to the top of the hill.

Shortly afterwards, the girl in the orange Pinto came back, and parked again. By this time there was a boat being pulled out of the water, sort of metallic brown and the pickup that was pulling the boat trailer was also a golden brown color, but not metallic. She stated it was possibly an 80-81 Chevrolet truck with mud grip tires on the back and that there were three subjects, two that she could describe, one as being approximately 5'7", 160-70, curly brown hair, medium length. The other guy was 5'5", slender built, straight hair below the ears. Could not see the other guy at all. She stated that when they pulled up to the ramp to load, they did not have their running lights on, that they had made some comment to one another about a billfold that they had probably lost, either in the truck or in the boat. She stated that she does not remember the girl talking to these guys that were loading the boat. However, it appeared that she had been waiting for somebody to come out of the water, and that as soon as the subjects had loaded up and pulled up, the girl fell in behind them and they left the park. She did not see whether she followed them out of the park area or not. She also stated that at one time when the girl came by their boat, that she had had a white glass or styrofoam cup in her hand. Does not know if it was a styrofoam drinking cup like are given in drive ins or what, but that this was the only occupant of the car, everytime that she came down, which appeared to have been 4-5 times.

She also stated that she remembers seeing the brown V hull boat near Koehne earlier in the night, while they had been skiing in that area. Arrangements have been made with DET. LUEKE to be in at 10A, Wednesday, 7-28-82, to put MISS HOSKINS under hypnosis to see if she can recall anything about the incident that she saw. It is believed by this officer that the information given by MISS HOSKINS could be very well true, being that she was at the Midway Park with a married man, and that they are worried about word getting out that they had been out there together, and they are being cautious and still came forward and gave us the information. This is the reason that I feel that it could be very good information that is being given by these people about seeing the car at that location at that time.

At 9:48A, 7-26-82, I had an interview again with a MIKE SUTTON of 1123 Proctor, ph/755-6408,

dob 7-9-64. He stated that he had been in a disagreement with a RAY OREGON, white male, 16yr and a JOHN LAVITT, white male, 17yos, and that these two subjects had stolen his money approximately a week and a half ago at the Rainbow Drive In grocery, and that he had threatened to whip their butts if they messed with him anymore. I had made arrangements to talk to SUTTON after I had received a knife from a MR. CECIL MONTIOYA, who is employed by SLADE SIGN COMPANY on Hodde Street. MR. MONTIOYA told me that after receiving this knife from MIKE SUTTON, one day last week, which he described as a , two blade knife, and after opening it appeared to have some blood on the nail grips on the blade. However, he had since then washed the knife and had removed the blood. I did check the knife itself and found it to have about a 3 1/2 inch blade, about 5/8's in width, being too short for the knife that is described as the murder weapon by pathologist.

However, I did call SUTTON in and after discussing it to him as to how the knife had gotten blood on it, he advised me that he had gone fishing on July 11th, and that he had cleared some fish and this is probably where the blood came from. He stated also that he had given the knife to MR. MONTIOYA after he had called out one of the employees at Slade Sign Company to fight him, and that he was afraid if he kept the knife he might use it on the subject. That the subject, known as BILL JONES, had made several remarks to him about him being crazy, and queer and such and that he had had enough of it, and he was not going to take anymore from the subject. However, the next day on the Thursday, July 22nd, he had been laid off from work for not working fast enough.

Also asked him at this time about the information that he had given me previously, about a subject by the name of TONY that had a fight with KEN FRANKS. He, at this time, told me that he had made a mistake with the name, and that the name is now known to him as BOBBY which is going to be a subject by the name of BOBBY BROWN, who drives a black Pontiac, and that this fight happened sometime around December 1981.

At approximately 10:40A, LT. HORTON asked SGT. FORTUNE and myself to check on a LARRY McBRIDE who had been picking up young girls at the Koehne Park and taking them boat riding, who they said might have some information in reference to this case. I called the Lone Star Gas Company where I found out LARRY McBRIDE is a meter reader, and was at the present time working a route in Hewitt, and had truck #22015 with him. SGT. FORTUNE and myself then found LARRY McBRIDE

McBRIDE about the case and he advises that he had been several times in Koehne Park in the past 15 years and he does take young girls riding and skiing. He stated that he had been in Koehne Park approximately 4P, and had left about dark, on Tuesday, 7-13-82, and that he does not remember seeing any orange cars or any girls resembling the girls in the pictures that we showed him of RAYLENE RICE and JILL MONTGOMERY. Also, does not remember seeing KEN before. He did state that he had a girl by the name of DONNA, and SHARON, who are Richfield High School Students, who had been with him on that Tuesday possibly, and that he had taken so many girls that he does not remember what the names are, only knows them by first names. He did state that if he made contact with them again, within the week, that he would tell them to contact our office to see if they are going to remember seeing anybody at this location. MR. LARRY McBRIDE lives at 5617 Bishop, res.ph/772-6190. He is a white male, dob 4-7-41.

At 11:40A, 7-26-82, we did go by 1520 Peach to see if we could locate TOMMY EKOLS. However, he still was not at home. Did notify his mother to have him call us as we wanted to talk to him in reference to this incident.

At 1:36P, I called MISS NANCY SHAW in Waxahachie, who is the mother JILL MONTGOMERY. She told me that she had heard from a friend of her sisters who had a guy by the name of DAVID HARTLEY working for her, that DAVID HARTLEY lived in Duncanville, ph/214-296-5589, and that he lives next door to a subject who had told him that the two girls, RAYLENE and JILL had been by his house on the day before the murders and that this date, DAVID HARTLEY had become suspicious because the other subject named DAVID, whom the girls were supposed to have seen on the day before the murders had gotten very jittery and nervous, and that he has learned since then that the subject DAVID, last name unknown, has since then moved out without any forwarding address from his apartment in the middle of the month. MISS SHAW also told me that she had found a not with the name of DANA MILLER of 919 Thistlegreen in Duncanville, with #214-298-4886, who might have possibly some connection with this guy named DAVID. I did advise MISS SHAW to have this subject, DAVID HARTLEY, call me directly to avoid any stories being told by either one of these witnesses and being stretched out by other people, that I needed to talk directly with him for him to tell me exactly what he had seen, or heard, in reference to this guy, DAVID. Have not received any information from either of them.
