On 7-26-82, at 2:30P, I contacted a female by the name of JOY THRASHER. She is a W/F, 17 yoa, home phone 753-8487, business phone 756-7291 at HOME CRAFTSMAN CENTER. She related to me that she knew a Subject, DANNY SIZEMORE, that he and KEN were the best of friends and had run around together quite a bit. She told me that DANNY SIZEMORE's parents, NORMA and DAVID SIZEMORE live at Rt. 1, Axtell, Texas and that their phone number was 822-1411. She stated as far as she knew that DANNY SIZEMORE was still in Alabama, that the last she heard he was there was in April of 82. She also further stated that she had talked to DANNY SIZEMORE's parents on Monday, July the 19th and they had told her they had talked to DANNY Friday night, July the 16th, that he was in Alabama. I have still been unable to get ahold of NORMA and DAVID SIZEMORE's parents to confirm whether or not they talked to their son in Alabama, whether he called them or whether they called him. At 3:30P on 7-26-82, I had a female who lived at the METHODIST HOME come to the Waco PD. Her name was CHRISTINE MARIE HART, W/F, 17 yoa. She stated that approx. 2 to 3 weeks ago that she had seen DANNY SIZEMORE on Valley Mills Drive, that she had talked to him, that he was standing in front and by the BURGER KING and Valley Mills and Wooded Acres. She has known DANNY SIZEMORE for many, many years and advised that she was not mistaken about who it was she saw. She related to me some other names which I have been unable to find any information on, a DANNY MCGENNIS and DANNY McSPADIN and a ROBERT HURNICUT. Apparently, these were some more friends that ran around with KENNETH FRANKS and DANNY SIZEMORE. CHRISTINE advised me that they did smoke joints and take a few pills every now and then. She also added the name of HENRY JOHNSON. She told me that all of these Subjects had engaged in several different types of wild games. She stated they would take a loaded pistol and get in a maze and the Subjects would blindfold the Subject with the pistol and the others would hide and as soon as he heard a noise that he was supposed to turn and shoot toward the noise and they made game out of these to enhance their sexual activities and their thrills. It is not known if CHRISTINE HART was exaggerating the truth or if this is actually the way that it actually happened. She told me that it had to be on Friday or Saturday night that she saw DANNY SIZEMORE on Valley Mills because this was the only nights that she ever went out on Valley Mills Drive but it was approx. 3 weeks ago. She has no idea where DANNY SIZEMORE is at this time, who he is living with but it is her belief that he is living with DANNY McSPADIN if he is in Waco. She told me that DANNY SIZEMORE and his parents did not get along. They did not approve of his drugs or his being engaged in these exciting games, as she put it.
