In the fall of 1979, I can't remember the year exactly, but me, Otis, Frank and Becky picked this boy and girl up around 11:00 P.M. south of Georgetown. They were standing in front of a two tone blue car and said they wanted to ride to the next town because they had car trouble. We passed thru Georgetown north-bound on IH 35 and turned onto a paved road to the right. The boy had been tied up by Otis

Previously and when we stopped, Ottis had anal sex with the boy. He untied him and he started to run and Ottis shot him down. We had a .25 and .22 cal auto-matic and I'm not positive which one was used. After the boy was shot down and lying face down in the ditch, Ottis went thru his pockets and got some money and took his wallet out and then shot him some more. Me and Frank was holding the girl and Bechy was holding the door so she couldn't get out.

We left there and drove on up I-35 about 60 miles, took an off ramp, went by an overpass and I shot the girl on the access road. I shot her out the window & remember that she had something in her hands, I don't remember.
