Myself and Lt. RIGNEY did go to Waco High School, where we contacted a Ms. AGNES TALLEY. Ms. TALLEY is a counselor at Waco High School, phone number 756-7211. Ms. TALLEY advised that she had a WM being a TERRY LEHRMAN of Rt. 3 Box 515 - Waco, Tx. being approximately 17 to 18yoa, 5-6 tall, 130 to 140 lbs. with bushy blonde hair. Ms. TALLEY said that LEHRMAN asked the secretary who is a Ms. CLYNCH who only works part-time if he could speak to a JILL MONTGOMERY. Ms. CLYNCH then went and got Ms. TALLEY from her office and brought her out to speak to Mr. LEHRMAN. Ms. TALLEY went on to say that LEHRMAN asked her if he could see JILL MONTGOMERY. Ms. TALLEY asked Mr. LEHRMAN why he needed to see Ms. MONTGOMERY and if he lived or went to school in this area. He stated that he did live in this area and did go to school in China Springs, and that he just needed to see Ms. MONTGOMERY. Ms. TALLEY then went on to ask Mr. LEHRMAN if he was in the Waco area this summer and he stated that he was. She further asked him then if he read the newspapers or was aware of a triple murder that had occurred this summer in the Koehne Park area and he stated yes, but that he just wanted to see JILL MONTGOMERY and did not know what the hassle was. When LEHRMAN was advised that Ms. MONTGOMERY was one of the subjects murdered in Koehne Park, he gave somewhat of a strange facial reaction and then told Ms. TALLEY, that he had made a mistake and he wanted to see JOE MONTGOMERY. There is a JOE MONTGOMERY who is a BM registered as a student at Waco High School. However, Ms. TALLEY refused for the subject LEHRMAN to see either subject and told him that he did not leave the school premises, that the police would be called.

Ms. TALLEY sated that the subject then left the school area. She did not see whether or not he was driving a vehicle and this is when she called and notified us of the occurrence.

I did further check with China Springs High School. They stated that they did have a TERRY LEHRMAN, WM, DOB/2-28-64 residing at Rt. 3 Box 515 in Waco registered as a student. However, he was out of school on this date and has a very poor attendance record. The secretary at China Springs High School also advised me that Mr. LEHRMAN's parents are split up and he may either be living with his father or mother. They do not have an address on Mr. LEHRMAN's mother. TERRY LEHRMAN also has a brother named JERRY LEHRMAN who is a year younger and also attends China Springs High School.
