On 7-14-82, at 2P myself and DET. FORTUNE went back to Koehne Park where we did contact OFFICER NICOLETTI who did take photographs of the orange Pinto and also fingerprint the vehicle for any possible fingerprints.

At 2:55P, 7-14-82, I recontacted NANCY SHAW at ph/214-937-8336. She told me that her daughter was to come to Waco on 7-13-82, with RALENE RICE, to pick up a check at City Hall for approximately \$300.00. That this was a check where her daughter had worked on the CIA program and had worked at Ft. Fisher. This was to be her final check. She did not know whether the check was picked up or not. Said she has not heard from her daughter, and this is very unlike her daughter.

At 3P 7-14-82, I recontacted MR. RICE at ph/214-937-8424. He told me that his daughter was to take JILL MONTGOMERY to Waco Texas to pick up a check at City Hall on 7-13-82. He did not know where they had gone after that. He told me that it is very unlike his daughter not to call him. That she has spent the night away from home before, but she usually calls him and this is very unlike her. I did tell him that we were picking the vehicle up and it would be in our custody.

On 7-14-82, at 3:10P, I recontacted RICHARD FRANKS, 2804 Savannah Court, ph/776-4820, bus. ph/776-4820. He told me that he still had not heard from his son. If he heard anything at all he would recontact the Police Department. I told him that we would be working on the case.

When I talked to NANCY SHAW, she told me that she would be coming to Waco on 7-15-82, and that she would bring a picture of RALENE RICE and JILL MONTGOMERY.
