Officer SALINAS and MYSELF went to Rosebud where we recontacted the subject CHARLES ALFRED RAMSEY. We talked to him at approx. 5:15PM. He went back over some of the information that he had related to me in a little more detail. He stated he was in Waco to bid for a job at General Tire. But that he had refused to cross picket lines to do any work if it meant crossing the Picket lines. He further related to us that he drove up to University Parks Drive by the Convention Center and the Hilton, that some shriners were riding their motorcycles out on the parking lot of the convention center, practicing their maneuvers. He stated he pulled into the parking lot and watched them practice for a short time. From here he drove around attempting to find a park area where he use to years ago when he worked for the Nuclear plant at Glen Rose, he would park here and sit at the park and sleep a little on the way back and forth to the job at Glen Rose. He stated while he was driving around that he pulled into the area which he found to be Koehne Park. This was approx. 5:00P and no later than 5:30PM according to him. He has no wristwatch and the clock on his dash does not operate properly and that the time is usually wrong. He stated when he pulled into the park he pulled around by the Circle and as he pulled in that the orange Pinto in question was already at the Circle parked facing in towards the lake itself. He pulled up on the left hand side next to a picnic table and directly in front of him at another picnic table were five black subject's, two females and three black males. He stated that they were playing music and getting kind of loud, smoking joints and what have you. He further stated that to his left on a picnic table was a pair of brown look like Wellington work boots. While he was there he stated he was not there very long, an old car, color he does not remember, pulled in and parked directly behind him. A subject got out of this car and walked over to the picnic table where he took out some food and ate. He stated this subject looked to be about 20 to 25 yoa, W/M. That as soon as the subject finished eating, he got back in his car and left the scene. He never saw this car again.

Directly to the right of him with no cars between him was parked the orange Pinto. On the other side of the Pinto toward the crest of the hill facing towards the Wooded area was an old dark car and then on around to the right facing directly up the hill was a yellow car. He believed it to be a fairly new 2dr Sedan.

He got out and walked up to the top of the hill to the farthest picnic table on the top of the hill before you start around the curb being to the right of where his car if you were walking around the circle, to the farthest picnic table up on top behind the dumpsters and he sat at this location for quite some time looking through his binoculars watching boats and skiers and what have you. He stated that several cars had pulled in, stopped and had left, pulled in and stopped and left. He stated prior to dark that a light gray or silver car had pulled in and that there was two white males in this vehicle. It pulled in between his Truck and the orange Pinto and parked there for a while. This car backed out and left and was gone for quite some time. However, he stated right at dusk or right by dark that this car pulled back in, had stopped and sat there for a extended period of time, but that he did not remember either subject getting out of this silver or light gray colored car. He said just as it got dark or shortly after dark all five of the blacks got into the yellow car, had backed out and left the circle area and did not return to his knowledge the entire time that he was there. MR. RAMSEY stated that he had dozed off and woke up several times during the period of time that he pulled in until around midnight when he woke up. But right after dark he got up and walked around a little and then walked back to his Truck and got into his Truck. He stated at this time that there did not appear to be anyone out walking around in the area.

He stated that he does not remember if another vehicle pulled up or what, but that he heard noises at the picnic table just to the right of the one that he was sitting at on the hill and he looked and there was two couples seated at the table up on this hill. He said he cannot remember anything about these two couples other than that they were laughing, giggling and carrying on. That he believes it was two females and two males and he thought one of them might have had on blue jeans but he could not be for certain. He stated he kind of dozed off again and a vehicle pulled in and parked right next to the Pinto and a boy and girl got out of the car and walked down toward the Lake. He stated they stayed down there for approx. 15, 20, 30 minutes, he was not sure how long. They walked back up the hill, got in the car, backed out and left. He does not remember seeing any white Van or anything of this nature. He said the only dark colored Van he remembered was a brown short bed Van, dark brown in color. He stated it was well customized and had two big picture type windows on the side of the Van.

He stated that he did take a nap before it got dark or the late in the afternoon when he was on the picnic table that he had put his head down and went to sleep. But that when he woke up he went back to the Truck and it was around 9:30PM when he dozed off again. He said he woke up around 11:30 or 12:00, went to the Elite at the Circle and ate. He could not remember seeing any one wearing the type of clothing that the two females had on walking around at any time while he was there awake. MR. RAMSKEY advised us that he would agree to be hypnotized in an attempt to pull more information from him, that he just could not remember because he had really not payed that much attention to any of the cars that had come and pulled up beside each other and talked and then pulled out again. He stated this went on nearly all night. He does recall hearing what he thought was a Police radio sometime after dark, pull in and circle around and then leave. He did not raise up and look to see, but said he thought it sounded as though a Police radio or CB was talking.
