On this date, 8-11-82, at 1:15P, I contacted a BRADLEY POTTER, in the criminal investigation division of Ft. Hood Texas, area code 817-685-5039, and requested that he give us all the information he could obtain on the subject DANNY SIZEMORE, white male, social security #450-43-2231. He stated he would get the information to us as soon as he could get it all put together.

On 8-10-82, at 1:15P, I talked with a subject, WELDON BOUNDS, white male, 19yca, who works for Bounds Automotive at 753-5315, his home ph/752-7001. MR. BOUNDS related to me that on the date of 8-9-82, late in the evening, somewhere around close to dark he had talked to JOY THRASER at the Northwood Apartments. He stated that she had related to him that DANNY's parents did know where DANNY SIZEMORE was, and he stated that it is his opinion that probably JOY knew where DANNY was, also, and that she had probably talked to him sometime in the last two weeks. He stated that he felt that she was indicating that DANNY may know something concerning the triple murders in Koebne Park, but that he had no basis to base this on, other than the fact of the way she was very evasive about the questions which he was asking her. He advised that he wished that his name not be mentioned unless it is absolutely necessary in questioning JOY THRASER in reference to this.
